About this Issue

The quest for a well defined political status continues in the 'Northern Areas.' The Karachi Agreement has been vehemently criticized all across on account of its failure to ensure basic political and economic rights for the people of this region. Political groups such GBUM and BNF consider Pakistan's control over these areas as illegitimate and seek independent status. A new constitutional package has been promised by the government of Pakistan as is indicated in one of the reports in this issue. Ironically, such packages in the past have been of little value in availing fundamental rights for the deprived sections of population.

There is prevailing dilemma in the judicial system of the so called 'AJK' on whether the Supreme Court of Pakistan has jurisdiction over 'AJK' cases. There is infighting amongst judges in 'AJK' regarding seniority and related issues which explains the absence of proper justice and order.

China is making the most of this political perplexity and investing heavily to strengthen its ground in the region known to be economically viable for its trading activities. With Pakistan, it is in the process of exploring more avenues in the 'Northern Areas' for eco tourism leading to economic development.

"NALA should pass coming package: PM," Weekly Baang, May 19-25, 2009

ISLAMABAD: Prime Minister Yousuf Raza Gilani directed the Ministry of Kashmir Affairs and Northern Areas (KANA) to propose a comprehensive package to address the problems of the people of Northern Areas to be approved by the cabinet. Gilani assured a delegation of the Northern Areas consisting of Northern Areas Legislative Assembly (NALA) Speaker Malik Maskin, PML-Q's in-charge for the region Marvi Memon, adviser on health Haji Abdul Quddus, adviser works Ibrahim Sanai, adviser finance Mirza Hussain and others of his support on various administrative, political and development issues relating to the region during a meeting in Islamabad. Sources stated the prime minister agreed that the issue of constitutional rights of the people of the Northern Areas needed immediate attention and the government would give preference to an Azad Jammu and Kashmir-like government in Northern Areas under its proposed package. On the issue of changing the name of Northern Areas to Gilgit-Baltistan as per resolutions of the NALA, Gilani assured the issue

would be taken up in the cabinet committee meeting. He also ordered the PIA to increase daily flights to Gilgit and Skardu from two to three daily to lessen the problems of the people and facilitate the tourists.

Zaresh Khan "Bhasha Dam and Foreign Involvement," Kashmir Watch, May 19, 2009

Dams are an instrument of development, yet every dam small or large carries inherent risks of failure. In the case of a larger dam it could be catastrophic for life and property down the valley. Large dams are therefore planned and designed with utmost care to preclude as far as possible any risk of a failure. Keeping in view the risk factor and the growing population of Pakistan (estimated at 170 million at the start of 2009), the proposal of Bhasha dam was regulated on 17 January 2006. Inhabitants of the area welcomed the government proposal being truly patriotic.

The project of Bhasha Dam is located on Indus River, about 315 km upstream of Tarbela Dam, 165 km downstream of the Northern Area capital Gilgit and 40 km downstream of Chilas. The proposed dam would have a maximum height of 270 m, and impound a reservoir of about 7,500,000 acre feet $(9.25 \times 109 \text{ m3})$, with live storage of more than 6,400,000 acre feet (7.89×109 m3). Mean annual discharge of Indus River at the site is 50,000,000 acre feet (6.2×1010 m3). Thus the dam will impound 15% of the annual river flow. The dam project would cover an area of 110 km2 and extend 100 km upstream of the dam site up to Raikot Bridge on Karakoram Highway (KKH). The planned 4,500 MW Diamer-Bhasha Dam on the Indus in Pakistan is, at US\$12.6 billion, one of the largest and most costly planned dams in the world.

ISLAMABAD: Seeing genuine enthusiasm in traders' communities on both sides of the Line of Control (LOC) in Jammu and Kashmir, respective authorities agreed to increase the intra-Kashmir trade volume, reports stated. Under a bilateral accord reached between President Asif Ali Zardari and Indian Premier Manmohan Singh in New York on September 26, 2008, both Pakistan and India had allowed intra-Kashmir trade which went operational on October 21, 2008. The present operative trade routes are Muzaffarabad-Srinagar and Poonch-Rawalakot.

Since its start, the barter intra-Kashmir trade this far has crossed the monetary volume of over Rs.40 million per week. The items included in the expandable trade list are local Kashmiri farm products and handicrafts.

"UNICEF admits cheating children in Kashmir," Kashmir Watch, May 17, 2009

UNICEF admitted that it distributed hundreds of thousands low quality blankets to children who survived October 8, 2005 earthquake. These blankets were distributed during the winter season in the year 2006-almost a year after the earthquake. It was first pointed out in November 2006 that the UN agency was giving out low quality blankets to earthquake survivors. On November 27,2006, Ainga Razafy-the then logistic officer UNICEF Islamabadpointed out in her email to Anna Spindler the then logistic officer UNICEF field office Muzaffarabadthat blankets were not of a good quality.

"Pakistan, China working on clean development mechanism," Daily Times, May 12, 2009

ISLAMABAD: Pakistan and China will enhance cooperation to devise a clean development mechanism and establish protected areas in Khunjerab National Park (KNP) in Pakistan and Taxkorgan Nature Reserve (TNR) in China. The two endorsed the idea that scientists of both countries should promote exchange of information on key wildlife species and their habitats in the border region and that they should also explore possibilities for promoting eco-tourism in areas between Kashghar and Gilgit as a tool for economic development.

Any person from any part of the country with or without a relative on the other side can now travel on the Srinangar-Muzaffarabad bus. The Ministry of External affairs has done away with the tiresome procedure of verification and re-verification. Instead there will be a triple permit system which means a person with just 2 references from PoK can travel to and fro three times without renewing the documents. Passport officer, J-K B S Manavalan said, "Any Indian can travel on the bus, it was not so earlier. Only thing is that it will be up to PoK authorities whether they issue permit or not."

Pakistan occupied the territory as a result of tribal invasion in 1947 engineered by the Pakistani army. It covers one-third of the total area of 86,023 square miles/ 222,236 square kilometers of the state of Jammu & Kashmir. The area under occupation comprises two administrative units: Mirpur- Muzaffarabad and Gilgit Baltistan referred as 'Azad Kashmir' and the 'Northern Areas' respectively by the government of Pakistan. Pakistan ceded a segment (2,700 sq miles) of this occupied territory lying to the north-east border of the Northern Areas known as the Trans Karakoram Tract to China in 1963.

"AZAD KASHMIR"

Pakistan envisaged the Azad Kashmir as a country with a President, a Prime Minister and a Legislature of its own according to the Karachi Agreement of April 28, 1949. These structures and the designations are only titular in nature as this invaded territory is neither a country nor even a province. Significant subjects such as defence, supposed 'foreign policy' of POK, rehabilitation of refugees and the overall control have been carefully placed under the discretion of the political establishment of Pakistan.

NORTHERNAREAS

The **Northern Areas** officially referred to by the government of Pakistan as the Federally Administered Northern Areas (FANA), is the northernmost political entity within the Pakistan occupied part of Kashmir and is a self governing unit under Pakistani control. The area is five times bigger to that of Azad Kashmir. The status of this region being unstated in the successive constitutions of Pakistan over the years, the people are denied basic socio-political and legal rights. The Northern Areas have no representation in the National Assembly and are governed by the Northern Areas Council headed by Minister of Kashmir and Northern Areas. A Judicial Commissioner exercises judicial powers in the absence of a High Court. The population mainly comprises Shia, Sunni and Ismaili Muslims. Ethnic groups include Baltees, Shinas, Vashkuns, Mughals, Kashmiris, Pathans, Ladhakhis and Turks.

"Chief Minister": Irfan Ali and Shahid Hussain

Legislature: Northern Areas Legislative Assembly (29 seats)

Languages: Balti, Shina, Brushaski, Khawer, Wakhi, Turki, Tibeti, Pushto and Urdu
