In this Edition

The recently held elections in Pakistan has once again unleashed a debate on the constitutionally and identity of PoK, which neither participated in the elections nor its people got an opportunity to vote in it. Both the so called AJK and Gilgit Baltistan do not have representation in the Pakistan Parliament. In the wake of elections, a section of people has urged that relations between Islamabad and the so called AJK need to be revisited and redefined. They have demanded basic political rights which include empowerment and representation in the federal assembly of Pakistan.

PML-N (Pakistan Muslim League-Nawaz) 's victory in the elections has raised a great deal of apprehension in PoK as both AJK and Gilgit Baltistan currently have PPP-led governments. A leader of the local chapter of PML-N in PoK sent out signals, as reports suggest, that the government in the region could be overthrown. Later, PML-N chief and the newly elected prime minister of Pakistan, Nawaz Sharif, dismissed such claims. However, the search has begun to replace the governor of Gilgit Baltistan, Pir Karam Ali Shah, who took charge after the demise of the previous incumbent, Dr Shama Khalid, in September 2010. It is noted that PML-N is eyeing the top post in Gilgit Baltistan.

Meanwhile, the blueprint of the Bunji dam in Gilgit Baltistan, to be built with Chinese assistance, is complete. The proposed site of the dam is located in an area legally claimed by India. Therefore, in 2009, when the Memorandum of Understanding (MoU) for the Bunji dam, a 7, 100 megawatt project was signed between Pakistan's Ministry of Water and Power and Three Gorges Project Corporation of China, India raised serious objections on the issue.

"Blueprints of Bunji Dam complete"

LAHORE: On May 6, the Water and Power Development Authority (Wapda) announced that it has completed detailed engineering design and tender documents of the 7,100-megawatt (MW) Bunji Hydropower Project, and will soon initiate the process to undertake construction of one of the largest dams in Pakistan. Pakistan and China signed a memorandum of understanding for the Bunji Dam in 2009. The accord was signed between the Ministry of Water and Power and Three Gorges Project Corporation of China.

Wapda Chairman, Syed Raghib Abbas Shah broke this news in a meeting with Gilgit-Baltistan (G-B) Chief Secretary, Sajjad Saleem Hotiana, while discussing various Wapda projects located in the province. Speaking on the occasion, Shah stated that mega-dams such as Bunji and Diamer-Bhasha will not only help stabilise the economy but also help usher a new era of social and economic development in G-B. He also praised the G-B government's cooperation in implementing Wapda projects in the region. "Wapda will fulfil all its commitments during the construction of the projects in the province and resettlement of the displaced," stated Shah.

Shabbir Mir, "Counter-reaction: Mainstream parties shun reservations over self-governance order"

GILGIT: Leaders of mainstream political parties in Gilgit-Baltistan (G-B) shunned the reservations of religious parties against the G-B Empowerment and Self-Governance Order 2009, claiming the fault lies with the rulers and not the system itself. "There is

nothing written against any sect in the legislation, so we will not support any struggle on sectarian lines," stated Pakistan Muslim League-Nawaz's (PML-N) regional head Hafizur Rahman on May 8. Jamaat-e-Islami (JI) and Ahle Sunnat Waljamat (ASWJ) on May 7 observed a 'token strike' in parts of G-B against the 2009 legislation, asking authorities to revoke it and amalgamate G-B with Azad Jammu and Kashmir (AJK). They alleged the order and the chief minister were both biased and favoured a particular sect.

Some nationalist parties also joined the protest, carrying banners and convening rallies in valleys, including Ghizer and Diamer. The government shut down all educational institutions, markets, cellular services and the Karakoram Highway due to the protest as a precautionary measure on May 7.

Shabbir Mir, "Acting with caution: G-B politicians stay away from party campaigns"

GILGIT: With politicians under attack and threats looming large, most politicians from Gilgit-Baltistan (G-B) have refrained from attending ongoing election campaigns of their respective parties. In the past, several delegations from Gilgit, Skardu and other valleys of G-B used to participate in rallies, standing alongside their leaders and supporting their cause. However, recent threats have put the brakes on the trend.

"I don't think our presence in the cities will make any difference to our leadership," stated G-B Assembly Speaker Wazir Baig, who is also a local leader of Pakistan Peoples Party. "There are threats from extremists so it's better if we stay here," he noted while speaking to journalists at the Gilgit Press Club on May 3. Although Chief Minister Mehdi Shah is in Islamabad, the rest of the lawmakers including Governor Pir Karam have stayed back in G-B. In the 33-member G-B Assembly, 18 are members of the ruling Pakistan Peoples Party while the rest are affiliated with other mainstream parties.

B. Raman, "China Manoeuvres Against India's Possible Use of Gilgit-Baltistan Card"

China, which had never openly questioned the Indian estimate of the length of the common border before, is now unilaterally seeking to exclude from consideration during the border talks, the dispute between India and China over the Chinese occupation of a large territory in the Ladakh sector of J&K.

"In fact, it is seeking to question India's locus standi to discuss with China the border in the J&K area in view of Pakistan's claims to this area. It is trying to bring in Pakistan as an interested party in so far as the border talks regarding the western sector are concerned. "It wants to change the format of the border talks in order to keep it confined bilaterally to the eastern and middle sectors and expand it to a trilateral issue involving India, China and Pakistan in the western sector. "The exclusion of the border in the J&K sector from its estimate of the total length of the border is another indication that it does not recognise India's claims of sovereignty over J&K.

Shabbir Mir, "Gaining sympathy: Support for Musharraf escalates in Skardu"

GILGIT: Since the arrest of former president General (Retd) Pervez Musharraf, his supporters in Skardu have escalated their campaigns in his favour. The retired general faces three cases since he returned to Pakistan in March after four years of self-imposed exile. Musharraf's party, the All Pakistan Muslim League (APML) held four demonstrations in the town during the past two weeks, protesting against his 'illegal detention' with another one held on May 1. In an attempt to ban political meetings, the local administration has imposed Section 144. "We know the government is trying to restrain us from holding rallies but we will do it anyway," stated Manzoor Yoltar, the chief organiser of AMPL, a day after the Peshawar High Court imposed a lifetime ban on Musharraf to contest elections.

"G-B timber movement: Ministry chops up logging policy"

ISLAMABAD: While conveying the reservations of environmentalists on the recently notified timber movement policy, the Ministry of Climate Change has forwarded a summary to the Cabinet Division secretary to revoke the policy. The policy, which was notified by the G-B Council and approved by former prime minister, Raja Pervez Ashraf on his final day in office, allows for the transportation of around four million cubic feet (cft) of timber from Diamer in Gilgit-Baltistan (G-B) to others parts of the country.

Environmentalists fear the policy will lead to rapid deforestation in Diamer. In the absence of strict and scientific mechanisms to monitor the illegal felling of timber, environmentalists say forest contractors will cut down more trees illegally to replace those already transported. In an April 2013 meeting of the Senate Standing Committee on Climate Change, the ministry's secretary Muhammad Ali Gardezi stated that he would request the cabinet secretary to reverse the policy, citing the concerns of environmentalists and the risk presented to Pakistan's international commitments on deforestation.

A ministry official requesting anonymity confirmed that the summary had been forwarded to the cabinet secretary and a reply from the Cabinet Division was

expected soon. Meanwhile, civil society organisations in Islamabad such as the Sustainable Development Partnership Institute (SDPI), Akhtar Hameed Khan Resource Centre (AHKRC) and the Himalayan Wildlife Foundation (HWF) have been campaigning against the harmful effects of the timber movement policy.

"I.B.M. powers Pakistan's first hydropower plant"

May 6, 2013

I.B.M. has been selected by utility Tenaga Nasional Bhd Remaco to operate Pakistan's first-ever private sector hydropower plant. The 84-megawatt New Bong Hydroelectric Power Complex, which started commercial operation just this March, will replace 135,000 tons of imported oil and save Pakistan around \$100 million in fuel costs annually.

Located on the Jhelum River in Azad Jammu and Kashmir, the hydroelectric project will help Pakistan meet its growing energy needs by adding an estimated 540 gigawatt -hours of energy to the national grid, as well as enhance the water power generation capacity of independent power producers in the country by 40 percent. According to the Petroleum Institute of Pakistan, electricity demand across the country is escalating along with its rising population. The total power generation capacity of Pakistan currently stands at 23,538 megawatts, with energy consumption seen as growing 80 percent in the last 15 years. The country's electricity demand will increase to around 40,000 MW by 2020, estimated the Pakistan Water and Power Development Authority.

"Court reinstates 183 sacked teachers"

GILGIT: The Chief Court of Gilgit Baltistan reinstated services of 183 teachers on May 3, who were dismissed a month before by the higher authorities of Education Department. Sources stated that on March 14 senior authorities dismissed

183 teachers declaring their appointment illegal and without fulfillment of laid down procedure. The terminated teachers filed a writ petition in the Chief Court seeking relief.

Meanwhile, on March 23, the Chief Secretary, Sajjad Salim Hottiana withdrew the orders of Secretary Education and stated rules for termination of services were not adopted. The Chief Court while disposing off the petition stated that since the Chief Secretary has withdrawn notification of termination which was issued by Secretary Education, there is no justification to hear this petition.

"Power protesters thrashed in Mirpur AJK"

MIRPUR: Police thrashed the participants of a march protesting against worsening power crisis in

Azad Kashmir's Mirpur on May 27. The people of Mirpur observed complete strike and kept business centers closed against the unannounced and prolonged load shedding. Police resorted to baton charge against the protesters injuring scores of people tormented by 20 hours power shut down daily. Meanwhile, WAPDA after the protest declared Mirpur exempted from the power load shedding. A notification has also been issued to this effect.

Thousands of protesters staged march towards Mangla Power house against unannounced and prolonged load shedding in Mirpur. The police stopped the protesters four kilometers away from the Mangla Power house and started baton charge; meanwhile the protesters also pelted stones on the police personnel. Many police personnel and protesters were injured as a result of the clash.

"Neelum Jhelum project: China to provide \$448m for stepping up work"

LAHORE: Exim Bank of China will provide Pakistan \$448 million for the strategically important 969-megawatt Neelum Jhelum Hydropower Project and an agreement in this connection has been signed between the two sides. "This agreement is a significant development in efforts to secure financial resources for (completing) the remaining work on underconstruction Neelum Jhelum Hydropower Project," stated a press release issued by the Water and Power Development Authority on May 27. The Neelum Jhelum project, being constructed on the Neelum River in Azad Jammu and Kashmir, will not only produce low-cost hydroelectric power to ease electricity shortages in the country, but will also establish priority rights over water. India is also constructing a dam upstream of Neelum Jhelum project to complete it first and win rights over water.

Wapda stated that in view of the project's significance, it was making all possible efforts to remain within the timeframe and complete the

project by 2016. At present, according to Wapda, construction work on all sites is going on satisfactorily. Of the tunnels stretching over 67 km, 34.24 km (51%) have so far been dug, while excavation of an underground power house stands at 75.24% and transformers hall at 96.33%.

"Irsa reduces water releases from Mangla Dam"

The Indus River System Authority on May 27 reduced water releases from the Mangla Dam to the minimum level of 25,000 cusecs to fill the upgraded reservoir to the maximum level of 1,242 ft during next three months. Punjab Irrigation canal regulator engineer M H Siddiqui noted that the current flow in the river Jhelum was 77,000 cusecs out of which 52,000 cusecs water was being retained in the dam while 25,000 cusecs water was released for hydel power generation and irrigation of Kharif crops in Punjab. He further stated presently 383,000 cusecs water was running in the four live rivers of the country: Indus 149,200 cusecs, river Kabul 106,000 cusecs, Jhelum 77,000 cusecs and river Chenab 53,000 cusecs. Siddiqui noted since the Kabul river was significantly contributing to the water economy of the country, Irsa was retaining nearly 70,000 cusecs water in Tarbela Dam and stored 0.8 MAF water in the reservoir during past week.

Shabbir Mir, "G-B assembly congratulates PML-N for poll win"

GILGIT: On the fourth day of the first Gilgit-Baltistan (G-B) assembly session after polls, speaker Wazir Baig congratulated the Pakistan Muslim League-Nawaz (PML-N) and winning parties and hoped the incoming government of "would strengthen the process of accountability in the G-B region." Baig made these comments after Nawaz Khan Naji, one of the three opposition members in the assembly, felicitated the Nawaz government hoped it would pay attention to

reinforcing the National Accountability Bureau in G-B.

The outspoken Naji has time and again accused the government of patronising corruption in G-B. In the last meeting held on May 23, Naji had a fierce argument with the treasury benches after he defended the opposition leader Janbanz Khan who had earlier termed the cabinet members "dacoits" for their alleged massive corruption during the past three years. "At the same time we expect that the Nawaz government will not opt for any unconstitutional act against the assembly," Naji added.

During the session, Amina Ansari, a PML-Q legislator from Skardu, inquired into the promise of making Gilgit and Skardu airports 'all weather'. The central leadership of PPP, including Yousaf Raza Gilani, during election campaigns, had promised to make the two airports all-weather, a status that could ensure uninterrupted flights between the two regions even during rainy days.

Peer Muhammad, "Changing faces: Governor GB to be replaced"

ISLAMABAD: The race for the prized governorship of the country's alpine region of Gilgit Baltistan is in full swing, with aspirants jockeying for position as the incumbent Governor, Pir Karam Ali Shah is likely to be replaced soon after the new setup is installed in Islamabad. Shah, who was selected to be governor by the former Pakistan Peoples Party (PPP) government, assumed office in 2012 after the tragic demise of Dr Shama Khalid, the first Gilgit Baltistan governor.

The Gilgit Baltistan chapter of the Pakistan Muslim League Nawaz (PML-N) has recommended to its central party leadership the immediate replacement of Shah. Party affiliation and Shah's inability to meet the expectations of the region's people have been cited as the primary reasons for the change and PML-N leadership has agreed to materialise this suggestion after consultations. According to

sources, the party central leadership had offered the position to PML-N chief coordinator in Gilgit Baltistan, Hafiz Hafeezur Rehman. However Rehman, who has been with the party for over 13 years and remained loyal during turbulent times, has declined the offer citing the non-partisan nature of the office. With Rehman's refusal to give up his political activities, frontrunners in the race for the governorship now include former deputy chief executive of Gilgit Baltistan Mir Ghazanfar, former speaker legislative assembly, Malik Maskeen, senior PML-N leader, Sultan Madad and Dr Anjum.

Shahzad Raza, "MoIT tops the list of 'secret fund' distributors"

ISLAMABAD: It was not the ministry of defense or foreign affairs or interior. The ministry that handled the highest amount of secret funds since 2009 was the Ministry of Information Technology (MoIT). Surprising but true: the MoIT consumed more than Rs3 billion since 2009 under the head of a secret fund, an Auditor General report revealed. The report read, in the fiscal year of 2009-10, that MoIT was allocated Rs 1.329 billion of secret funds in the federal budget.

Official sources stated the MoIT was engaged in some concealed projects in Azad Jammu & Kashmir and the purpose of the secret fund was to fulfill the financial requirements without getting into the limelight. A Supreme Court bench comprising Justice Jawad S Khawja and Justice Khilji Arif is hearing petitions challenging the use of secret fund by the ministry of information.

ISLAMABAD: The Diamer Bhasha Dam project is a "life-line" for national economy which would help meet country's future agricultural and power requirements, stated officials of the Ministry of Water and Power. In response to a question, he stated the dam which will be built on the Indus River will generate 4,500 megawatts of electricity annually and enhance the life of Tarbela Dam, which is located downstream of the Diamer Bhasha dam, by over 35 years.

Ansar Abbasi, "World Bank trying to make Bhasha Dam controversial"

ISLAMABAD: After Kalabagh, the smooth and early construction of the promised Diamer-Bhasha Dam (DBD), which would produce 4,500MW electricity and store 8,000,000 acres feet of water, is being endangered both by the World Bank and the

present chairman of Wapda. An official note recently circulated by former chairman Wapda and presently adviser to the Ministry of Water and Power on DBD, Shakil Durrani, to all concerned reveals that the World Bank does not want the construction of the dam though the ADB and Friends of Democratic Pakistan are willing to finance the project.

"It is unfortunate that the World Bank is creating a controversy that might result in further delaying a project (DBD) which was unanimously endorsed by the Council of Common Interests and has a national consensus behind it," the adviser stated. The official note, which has been sent to the deputy chairman Planning Commission, secretary water and power, chairman Wapda and others reflects not only on the World Bank reservations on the Bhasha Dam but also discloses how in a high-level meeting the chairman Wapda recently preferred Dasu to Bhasha.

Peer Muhammad, "Emerging row: GB governor removal may raise constitutional issues"

ISLAMABAD: A constitutional issue seems to have emerged regarding the procedure for the removal of the governor of Gilgit-Baltistan (GB), as the Gilgit-Baltistan Empowerment and Self Governance Order-2009 is totally silent in this regard. The question is: should President Asif Zardari follow the recommendation of the upcoming prime minister and replace the PPPaffiliated governor of the GB territory with a PML-N nominee? The Pakistan Muslim LeagueNawaz (PML-N) leadership in GB was lobbying for removing GB Governor, Pir Karam Ali Shah, who was appointed by President Zardari and belongs to the Pakistan Peoples Party (PPP). In all four provinces of Pakistan, the governor is appointed and removed by the president on the recommendation of the prime minster, but GB is not a province but rather a self-governing territory.

Article-20(1) of the Gilgit-Baltistan Empowerment and Self Governance Order-2009, says "There shall be a Governor of Gilgit-Baltistan, who shall be

appointed by the president of Pakistan on the advice of the prime minister of Pakistan." The law does not however lay out the procedure for his removal from office. Article-20(2) of the GB governance order also says, "The Governor shall hold office during the pleasure of the president and shall be entitled to such salary, allowances and privileges as the president may determine."

Kashif Abbasi, "Nawaz not keen on overthrowing PPP govts in GB, AJK"

ISLAMABAD: Contrary to the wishes of party chapters concerned, Pakistan Muslim League-Nawaz has decided not to dislodge Pakistan People's Party-led governments in Azad Jammu and Kashmir (AJK) and Gilgit-Baltistan. Sources in PML-N stated in categorical words that the leadership had conveyed their message to AJK and Gilgit-Baltistan that Centre would not support any un-constitutional move for dislodging the stated elected governments.

Earlier, it was expected that after formation of government in Centre, the PML-N government with the support of other opposition parties would bring down the PPP-led governments in AJK and GB. However, sources in PML-N stated Nawaz Sharif told concerned party chapters not to make haste in bringing down elected governments. The sources further stated the PML-N leadership was of the view that in case other opposition party brought no confidence motions against the stated governments, the PML-N could think over it, but so far the PML-N was not interested in overthrowing governments.

Of the total 41 seats of Legislative Assembly of Azad Kashmir, PML-N holds 14. But Barrister Sultan Mehmood Chaudhry group with seven seats and Muslim Conference with five seats are in favour of tabling a no-confidence motion against the AJK Prime Minister Chaudhry Abdul Majeed.

"AJK cabinet meeting: Workers' wages raised to Rs9,000"

MUZAFFARABAD: The Azad Jammu and Kashmir (AJK) government has raised the minimum wages of unskilled workers from Rs7,000 to Rs9,000 per month. The decision was taken at a cabinet meeting which was presided over by Prime Minister Chaudhry Abdul Majeed on May 30. Minister of Education for Colleges Matloob Ingilabi and the Minister for Food Javed Bhudanvi briefed the media about the cabinet meeting decisions. They stated the cabinet has also approved the big city status for Kotli and Palandhri with the establishment of two information technology (IT) universities. The cabinet also discussed the blasphemy issue reported a couple of weeks ago, saying there was no such issue except a "bid to harm Pakistan-China relations."

The ministers stated the cabinet had decided to double the house rent of ministers from Rs25,000 to Rs 55,000. "The cabinet also approved the Azad Kashmir Privatiaation Commission Ordinance enabling government to use the all open government land in different districts of Azad Kashmir," the ministers added. The ministers stated the AJK government is committed to rehabilitate the Kashmiri refugees who crossed the Line of Control (LoC) in 1990s. They would be given National Identity Cards (NICs) to get the benefits equal to the citizen of Azad Kashmir to live normal life wherever they want to live in AJK and Pakistan.

Gilgit-Baltistan might be the last thing on the minds of Pakistan's election-contesting parties none of them have included these far-flung northern areas in their manifestos but its more politically inclined residents are keeping a close eye on who gets to form a government in Islamabad come May 11.

"Our fate-politically, economically, legally remains in the hands of Islamabad, thanks to the quirks and tragedies of history," says Tahir Hussain, a Skardu resident. "We might have nothing to say we will not be voting but the next election will

matter. The new government in Islamabad could help enshrine, or remove, our rights."

While the rest of the country goes to the polls, the two million-strong population in this northern mountain range will have nothing to say when it comes to deciding who gets to sit in power in Islamabad. Its marginalisation from Pakistani politics is nothing new. In 1948, when this area acceded to Pakistan, it was promised constitutional recognition by the Pakistani state. Instead, Pakistan linked Gilgit-Baltistan to Jammu and Kashmir, hoping to ensure a favourable vote for the latter to accede to the newly formed Muslim nation in case a United Nations-promised plebiscite, meant to clarify whether Jammu & Kashmir belonged to India or Pakistan, took place. "The people of the region have since been bearing the brunt of this flawed policy and resultantly, the constitutional status of Gilgit-Baltistan has been in limbo," stated Syed Ansar Hussain, a resident of Gilgit-Baltistan.

The most intriguing part about the campaign against Kalabagh Dam has been to publicise that a dam much bigger than Kalabagh could be built on Indus at a site called Diamer Bhasha located 197 miles upstream on Tarbela. The dam was billed as a monumental structure, largest of its kind, and capable of resolving all the existing energy and irrigation problems. This fact cannot be ignored. Neither can be ignored the other vital factors, such as building cost, very difficult access to the site from Punjab, no availability of foodstuff in the vicinity of the dam area, as well as the non-availability of trained personnel in the northern areas where the dam will be located. As regards, the building cost of the proposed Bhasha Dam it is estimated to be \$14 billion. Compare it with \$352 million cost of Mangla Dam and about \$800 million of Tarbela Dam. The latter does not include the cost incurred by the continuing repair work in the tunnel area.

The extremely difficult access has to be a 200-mile long road that, considering the rocky terrain around the dam sites, will cost substantial additional funds. Transporting heavy equipment from some point on the national highway or the motorway to Bhasha would be a monumental job.

LONDON: Condemning the brutal murder of Kashmiri nationalist leader Arif Shahid on May 13, the Kashmir National Party (KNP) observed a five-day long hunger strike outside Pakistani High Commission in London from May 20. Shahid, who led the All Parties National Alliance (APNA), was killed by unidentified men outside his home in Rawalpindi, Pakistan.

In a press release, Dr. Shabir Choudhry of the KNP stated, "He spoke for the oppressed and victimized people of Jammu and Kashmir, and strongly advocated for rights of the people of Gilgit Baltistan as well. He was elected the Chairman of All Parties National Alliance which opposed the Pakistani occupation of Azad Kashmir and Gilgit Baltistan; and wanted closer ties between people of these two regions".

"GB upper areas roads blocked due to mudslides"

ASTORE: The upper areas of Gilgit-Baltistan remained cut off from the rest of province on May 26 as all the roads leading to the areas were blocked due to mudsliding and heavy snowfall. Torrentail rain continued for the last two days in all the districts of GB. The Astore-Highway was blocked due to landsliding. The fruit crops have also been affected in the region. When contacted, officials of the People's Works Department stated the rehabilitation work on roads could not be started till the rain stopped.

Waqas Naeem, "On guard: Glacial flooding: preparing against imminent threat"

ISLAMABAD: Two early warning systems are expected to help vulnerable communities in northern areas reduce the risk of flooding from glacial lakes this summer. These are: increase in weather monitoring stations and awareness-raising activities. These steps are part of the ongoing Pakistan Glacial Lake Outburst Flood (GLOF) project being implemented by the Ministry of Climate Change with technical support from the Pakistan Meteorological Department (PMD). In 2008, a lake at the Gulkin Glacier in Upper Hunza burst three times in two months, flooding the nearby village and destroying around 50 houses. The Korambar Glacier near Iskhoman Valley and the Buni Gole Glacier near Chitral generated GLOFs in 2010 and 2012, causing damages to agricultural land and settlements on each occasion.

Syed Mohammad Ali, "Need to curb deforestation"

Despite the significance of forests in helping preserve biodiversity, combating climate change and supporting people's livelihoods, Pakistan has not paid much heed to protecting its forest cover since independence, which has resultantly been depleting at alarming rates. Recent government estimates admit that the existing forest cover is insufficient. However, the official claims of forest cover (of around 4.5 per cent) are refuted by other estimates, which claim that this forest cover is no more than two per cent of the country's land mass. Considering the pace of deforestation, if the cutting of trees continues unchecked, Pakistan is likely to lose most of its forest within the next three or four decades as per assessments by the Pakistan Institute of Development Economics. Yet, relevant state authorities have been unable to curb deforestation in Gilgit-Baltistan, Khyber-Pakhtunkhwa (K-P) and Azad Jammu and Kashmir.

One of the major reasons for the decreasing forest cover is the absence of a comprehensive forestry policy. The attitude of politicians has also not shown much foresight. The chief minister of Punjab created quite a stir during his last stint due to a proposal to hand over forestry department land to agricultural graduates to undertake farming. Another controversial timber movement policy for Diamer district in Gilgit-Baltistan was approved by the outgoing prime minister, just a day before his term expired, which allowed the transportation of around four million cubic feet of timber from Diamer to other parts of Pakistan. Previously, the timber movement was restricted within Gilgit-Baltistan, as a measure to curb deforestation. Environmentalists and civil society representatives fear the movement is likely to increase illegal

logging because of weak enforcement and monitoring mechanisms. Even the newly-formed Ministry of Climate Change has opposed this policy and seems in favour of its reversal.

"Conference on linguists: South Asian languages fading out: experts"

MUZAFFARABAD: Of the 72 South Asian languages, only seven are still going strong in Pakistan. These include Kashmiri, Pahari, Gojri, Shina and Balti. Meanwhile, the rest are fading out due to phonetics formation among other factors. This was the crux of an international conference on linguistics held at University of Azad Jammu and Kashmir (AJK) on May 15. AJK President Sardar Yaqoob Khan attended the inaugural session and spoke about the Pahari language.

Dr Musawar, a prominent linguist and academician from Kashmir University Srinagar, presented a paper on the similarity of Shina and Kashmiri languages. He observed that both the languages have the same origin and need to be researched more. Migration is the main factor that changes the phonetics of any language and when the transformation occurs, in the phonetics then no one can ensure bright future of the language, he added.
