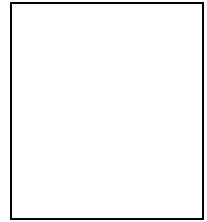

The IDSA publications can be obtained by Service Units/Establishments Messes directly by applying to become an Associate Corporate Member of IDSA for which, Service Institutions and other organizations dealing with national security matters are eligible. The concessional fee for such membership is Rs.400/- per annum and carries entitlement to free copy of two publications issued during the currency of membership.

Individual Service Officers, in their personal capacity only, are also eligible to become Special Subscribers to IDSA publications on payment of Rs.300/- per year, which carries entitlement to Strategic Digest/Strategic Analysis issued during the currency of the subscription.

3. The Subscription year in respect of both Associate Corporate Membership and Special Subscribership is based on financial year and becomes due for renewal on April 1<sup>st</sup> every year, irrespective of the date on which the initial subscription was paid. The IDSA is not in a position to supply from copies of back issues of publication to members/subscribers. These can, however, be supplied on payment, subject to their availability in stock.

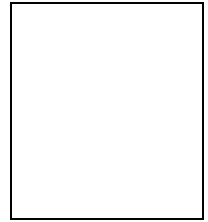
