

About this Issue

There are several reports in the issue which establish clear linkages between the PoK and the terrorist organizations operating in Kashmir and elsewhere. On the other hand, the suicide bomb attack in Muzaffarabad on June 26 seems to have ushered in a new struggle between the Pakistani army and the militants present in this region. Earlier, the army action against the Taliban raised skepticism amongst local population who were intrigued with such developments. They feared being killed on the pretext of the fight against militants as was done during Zia's authoritarian regime in the 1980's. The local political groups urge Pakistan not to interfere in the affairs of the region and they consider the constitutional packages offered to them as farce.

One of the reports in the issue again reaffirms India's contention about the mushrooming of militants' training camps in the PoK over the years. The growth in such clandestine activites could be attributed to the absence of any socio-economic development here. These training camps are an existential threat not only to India but to the overall security of the region.

Lastly, there are bright prospects for enhancing cross LoC in future trade even though it is facing few difficulties at the moment. At least the traders on both sides have shown adequate interest in this respect.

Gilgit-Baltistan, also called Federally Administered Northern Areas, was once a part of Jammu and Kashmir. "GB issues echo at interfaith meet in Geneva,"

BRUSSELS: Chairman Balawaristan National Front (BNF), Abdul Hamid Khan highlighted some of the burning issues facing Gilgit-Baltistan at a conference under Interfaith International held in UNHRC building in Geneva. In his long speech during the conference, Khan covered crucial areas such as judiciary, law and order, human rights, constitutional issues and unemployment and the sense of deprivation prevalent among the people of the region. He blamed Pakistan for the problems being faced by the region. He said judiciary doesn't exist as a full and independent department in Gilgit-Baltistan. There are two courts called Chief Court and Appellant Court, whose members (not called Judges) are appointed by the Pakistani minister for Kashmir and Northern Affairs on contractual basis. The judges' appointment is not made on merit basis rather solely on the political and religious considerations. Members/Judges loyalty is not with law or Justice but widely act under the direction from that minister and Pakistan's bureaucrats who are holding administrative, financial and judicial powers in the area. There is no freedom of expression in Gilgit-Baltistan. More than 200 political leaders and workers and religious people were tortured, sent behind bars and many were killed when they dared to express their views against Pakistan, he added.

"Leadership of Ghizer meets at Gahkuch to Discuss Security: Forces deputed to various border entry point,"

Religious Scholars, Members of Ismaili Council, Imams of the Mosques, Village Chiefs, social and political leaders called upon a meeting to discuss the recent threats of Taliban at Gahkuch, Ghizer. The Deputy Commissioner of the area briefed participants in the meeting about the plan to curb a possible aggression from across the borders of the Gilgit Baltistan area. The local leadership was told that upon the advice of the Interior Ministry, security has been put on high alert in various institutions including schools, offices, hospitals and mosques. Any suspect in the region shall be dealt with an iron fist. The government and public will jointly work for peacekeeping in the region. The Shia, Ismaili and Sunni leadership of the Ghizer had a consensus that an outsider would harm them only if an internal factor abets in the extreme and inhumane acts of the perpetrators. It was decided to depute the Gilgit Scouts to major entry routs to Ghizer area. The government also has decided to depute security forces to Batherate Nala, Darkot Pass, Singul Nala, Rawooshan and other possible entries into Gilgit Baltistan from Kalam, Sawat and Afghanistan.

ISLAMABAD: In a first suicide attack on soldiers in Pakistan-occupied Kashmir, at least two army men were killed and three others injured on June 26, army officials staetd. A statement issued by the army said a

suicide bomber blew himself up near an army vehicle at Shaukat Lines in Muzaffarabad, the capital of PoK. The bomber was described as a teenager. According to reports, local Taliban groups against whom Pakistan security forces have launched a major operation in north-western region of Waziristan, are behind the attack. Hakimullah Mehsud, a deputy of Pakistani Taliban leader Baitullah Mehsud, told a news agency that the attack was launched to prove that Mehsud had not been weakened by recent strikes on his suspected hideouts in northwest Pakistan.

"42 terror camps in AJK, alleges Indian agency,"

NEW DELHI: There are still 42 terror-training camps directed against India operating in Pakistan and the so called 'AJK.' This was the latest assessment of Multi-Agency Centre (MAC), the agency for all terror-related intelligence under the home ministry.

The MAC agency claims that there are 34 'active' and eight 'holding' camps operational across the border. Both Pakistan/Northern Areas and Pakistan-occupied Kashmir have 17 'active' and four 'holding or dormant' camps each, says the MAC assessment, based on inputs from Research and Analysis Wing, Intelligence Bureau, Military Intelligence and National Technical Research Organisation, among others. "It is estimated that around 2,200 militants are housed in these camps."

The observations are from a detailed secret report submitted to the region's government on the groups' activities in the city of Muzaffarabad and elsewhere. Pakistan banned the groups in 2002 after an attack on India's parliament brought the two states close to war. A senior Pakistani minister denied that such a report had been submitted.

"AJK bomber identified as Taliban from Waziristan,"

MUZAFFARABAD: The bomber responsible for the first suicide attack in Azad Jammu and Kashmir (AJK) was a member of the Taliban from Waziristan, an official stated on June 27. The blast on june 26 hit an army vehicle in Muzaffarabad, the capital of the AJK, killing two soldiers and wounding three others. "The suicide bomber had been identified as Abid. He belonged to the Taliban in Waziristan," said Raja Kafeel, the spokesman for the prime minister of the AJK. A Taliban spokesman on June 27 said the bombing was in retaliation for military operations against them.

"50 arrested in connection with Muzaffarabad attack"

MUZAFARABAD: Implementing stringent security measures large-scale police raids and arrests were made in Azad Kashmir Capital Muzafarabad after June 26 suicide blast. Muzafarabad law and enforcement agencies arrested 50 suspected men for having no valid identity papers, sources claimed. The entire state has been placed on high alert with intensified security checks on entrance and exit points of Kashmir.

When Pakistan and China signed MoU in 2004 for further expansion and upgrading of the existing Karakoram highway that links Gilgit to Kohat via Chitral, Dir, Swat connecting Gwadar to Western China, it alarmed many countries. US viewed the Highway project as alarming for its endeavours in exploiting the riches of CARs. India considered it as a dangerous development for its security. The Kashgar-Gwadar trade route affected the trade and economic interest of neighboring states of the region. Side by side, China started laying rail-link from Shanghai to Kashgar. In order to deny Chinese access to Gwadar and to stop Pakistan from exploiting economic benefit, the theme of provincial rights and backwardness proved quite successful.. However, the same strategy could hold the grounds in the tribal areas and NWFP. Therefore, keeping in view the environment of the area and emotional attachment of the people with the Islam, the propaganda theme regarding the presence of Osama bin Laden & al Qaeda leadership was blown out of proportion. The western media was already showing concern regarding militants' infiltration to orchestrate and launch cross-border attacks from their sanctuaries on Pakistani soil. Similarly, Afghan President Hamid Karzai accused Pakistan of alleged relationship between ISI agency and the militants.. Admiral Michael Mullen, chairman of the Joint Chiefs of Staff at Pentagon, US Gen. David Petraeus, commander Central Command, US think tanks and media cartels, questioned the alleged relationship between ISI and the militant Talibans.

"Pak, China sign loan agreement for \$300 million,"

ISLAMABAD: The Government of Pakistan has signed an MoU, with the Government of China on June 18 to reconstruct and rehabilitate three major cities of AJK destroyed in the 2005 earthquake, under AJK Urban Development Programme. The umbrella contract for this project has already been signed between ERRA and the two Chinese Construction Companies.

In order to assist the Government of Pakistan to complete the development work in the earthquake affected areas of Muzaffarabad, Bagh and Rawalakot, the Government of China offered credit worth US\$ 300 million, whereas the Government of Pakistan contributed additional US\$ 53 million to complete various reconstruction projects under AJK Urban Development Project.

Pakistan Occupied Kashmir-An Overview

Pakistan occupied Kashmir (PoK), legitimately an integral part of the Indian Union is presently under Pakistan's control. Pakistan occupied the territory as a result of tribal invasion in 1947 engineered by the Pakistani army. It covers one-third of the total area of 86,023 square miles/222,236 square kilometers of the state of Jammu & Kashmir. The area under occupation comprises two administrative units: Mirpur-Muzaffarabad and Gilgit Baltistan referred as 'Azad Kashmir' and the 'Northern Areas' respectively by the government of Pakistan. Pakistan ceded a segment (2,700 sq miles) of this occupied territory lying tothenorth-east border of the Northern Areas known as the Trans Karakoram Tract to China in 1963.

"AZAD KASHMIR"

Pakistan envisaged the Azad Kashmir as a country with a President, a Prime Minister and a Legislature of its own according to the Karachi Agreement of April 28, 1949. These structures and the designations are only titular in nature as this invaded territory is neither a country nor even a province. Significant subjects such as defence, supposed 'foreign policy' of POK, rehabilitation of refugees and the overall control have been carefully placed under the discretion of the political establishment of Pakistan.

NORTHERNAREAS

The **Northern Areas** officially referred to by the government of Pakistan as the Federally Administered Northern Areas (FANA), is the northernmost political entity within the Pakistan occupied part of Kashmir and is a self governing unit under Pakistani control. The area is five times bigger to that of Azad Kashmir. The status of this region being unstated in the successive constitutions of Pakistan over the years, the people are denied basic sociopolitical and legal rights. The Northern Areas have no representation in the National Assembly and are governed by the Northern Areas Council headed by Minister of Kashmir and Northern Areas. A Judicial Commissioner exercises judicial powers in the absence of a High Court. The population mainly comprises Shia, Sunni and Ismaili Muslims. Ethnic groups include Baltees, Shinas, Vashkuns, Mughals, Kashmiris, Pathans, Ladhakhis and Turks.
