Ambassador Sujan R. Chinoy

Manohar Parrikar Institute for Defence Studies and Analyses, India



Amb Sujan R. Chinoy is the Director General of the Manohar Parrikar Institute for Defence Studies and Analyses, New Delhi since January 2019. A career diplomat from 1981-2018, he was India's Ambassador to Japan and Mexico, and High Commissioner of India to Belize and the Republic of the Marshall Islands. A specialist on China and East Asia, he headed the India-China Expert Group of Diplomatic & Military Officials dealing with the boundary dispute and confidence-building measures. During his Foreign Service career, he served in Hong Kong, Beijing and as Consul General in Shanghai. He also served as the Consul General of India in Sydney.

He was India's representative to the First Committee at the UN dealing with disarmament and international security and later the deputy in the Indian Embassy in Riyadh. On deputation to India's National Security Council Secretariat, he anchored policy issues and strategic dialogues with counterparts around the world. He has rich experience in dealing with India's extended neighbourhood, terrorism and extremism, Indo-Pacific and maritime security, defence reforms and modernisation, infrastructure and connectivity. He is also the Indian Chair of the Think20 Engagement Group for India's G20 Presidency.

Mr Amitabh Kant is presently G20 Sherpa of India during its Presidency year. He was CEO, NITI Aayog (National Institution for Transforming India)- the Govt of India's premier policy Think Tank & prior to that Secretary, Department of Industrial Policy & Promotion. Amitabh Kant is a member of the Indian Administrative Service, IAS (Kerala Cadre: 1980 Batch).

He is the author of "Branding India – An Incredible Story", Incredible India 2.0 and has edited The Path Ahead "Transformative Ideas for India" and has been a key driver of "Make in India", Startup India, "Incredible India" and "God's Own Country" initiatives which positioned and branded India and Kerala State as leading manufacturing tourism destinations. These campaigns have won several international awards and embraced a host of activities – infrastructure development, product enhancement, private-public partnership and positioning and branding. Till March, 2016 Amitabh Kant was posted as Secretary, Department of Industrial Policy and Promotion (DIPP) – Government of India. He has worked as Secretary, Tourism, Kerala, Joint Secretary, Tourism, Govt of India, District Collector, Kozhikode & CEO, Delhi- Mumbai Industrial Corridor.

AMB HARSH VARDHAN SHRINGLA

Chief Coordinator for India's G20 Presidency in 2023



Amb Harsh Vardhan Shringla is a career diplomat and a member of the Indian Foreign Service since 1984. Currently, he is the Chief Coordinator for India's G20 Presidency. He has served as the Foreign Secretary of India from January 2020 to April 2022. Prior to that he was India's Ambassador to the United States from January 2019 to January 2020.

Amb Shringla has had a long and distinguished diplomatic career spanning over 37 years, having served in various positions across six countries. He has served in the Ministry of External Affairs, New Delhi as Joint Secretary (Director General) responsible for Bangladesh, Sri Lanka, Myanmar and Maldives. He has also headed the United Nations Political and SAARC Divisions in the Ministry. Earlier, he served as Director of the Northern Division dealing with Nepal and Bhutan and as Deputy Secretary of the Europe West Division.

He has published papers on conflict prevention, economic diplomacy, the Indian diaspora and India-Bangladesh relations. Amb Shringla speaks French, Vietnamese and Nepalese apart from English and Indian languages.

MR TETSUSHI SONOBE

Dean and CEO, Asian Development Bank Institute (ADBI) and Chair Think7



Mr. Tetsushi Sonobe is the Dean and CEO of the Asian Development Bank Institute (ADBI), the Tokyo-based think tank of the Asian Development Bank that promotes the realization of a prosperous, inclusive, resilient, and sustainable Asia and the Pacific through policy research and capacity building. Dean Sonobe obtained his PhD in economics from Yale University and BA in economics from the University of Tokyo. His research interests are centered on the empirics of economic development, particularly the roles of industrial clusters, human capital, social capital, management practices, and market competition in industrial development in developing Asia and other regions. Before joining ADBI in April 2020, Dean Sonobe served for six years as a Vice President of the National Graduate Institute for Policy Studies (GRIPS) in Tokyo and taught economics for thirty years at Tokyo Metropolitan University and GRIPS. He is a recipient of the Nikkei Book Publication Prize and the Masayoshi Ohira Memorial Prize, and a founding board member of the Japanese Association for Development Economics.

AMB VIIAY K. NAMBIAR

Principal Coordinator, C20, India's G20 Presidency



Amb Vijay K. Nambiar, born in Pune (1943), studied at St Xavier's College Mumbai. He was awarded the Chancellor's gold medal for his Masters in 1965. Joining India's Foreign Service in 1967, he studied Chinese and was posted to Hongkong and Beijing (1968-1972). After serving at headquarters, he was posted to Yugoslavia (1976-78) and the UN, New York (1979-82). His first Ambassadorial posting was to Algiers (1985-88), followed by Afghanistan (1990-92), Malaysia (1993-96), China (1996-2000) and Pakistan (2000-01) He was also Permanent Representative at India's UN Mission in New York. After retirement in 2004, he served as Deputy National Security Adviser until 2006 when he was seconded to the UN as Special Adviser to UNSG Kofi Annan. He was later Chef de Cabinet to UNSG Ban Ki Moon and his Adviser on Myanmar. He returned to India in 2017 and is now settled in Greater Noida.

AMB RAJIV BHATIA

Distinguished Fellow, Foreign Policy Studies Programme, Gateway House, India



Amb Rajiv Bhatia is Distinguished Fellow, Foreign Policy Studies Programme at Gateway House. He is a member of CII's International Advisory Council, Trade Policy Council and Africa Committee. He is the Chair of FICCI's Task Force on Blue Economy, and served as Chair of Core Group of Experts on BIMSTEC. He is a founding member of the Kalinga International Foundation and a member of the governing council of Asian Confluence. As Director General of the Indian Council of World Affairs (ICWA) from 2012-15, he played a key role in strengthening India's Track-II research and outreach activities.

During a 37-year innings in the Indian Foreign Service (IFS), he served as Ambassador to Myanmar and Mexico and as High Commissioner to Kenya, South Africa and Lesotho. A prolific columnist, he is also a regular speaker on foreign policy and diplomacy in India and abroad. He has authored three books "India in Global Affairs: Perspectives from Sapru House", "India-Myanmar Relations: Changing contours" and India-Africa Relations: Changing Horizons. His expertise covers a wide range of topics, such as the Indo-Pacific, South Asia, Southeast Asia, Africa, Multilateral Groupings, Indian Foreign Policy and Diplomacy, and major power relations.

Dr Sandhya Purecha, Sangeet Natak Akademi Awardee is a renowned Performing Academician, Bharatanatyam Guru, Performing Artist, Innovator-Choreographer, Prolific Writer and an Avowed Scholar - Researcher of Sanskrit vis-à-vis Indian classical dance. She is the Managing Trustee & Secretary of Sarfojiraje Bhosale B.N.T. & R. Centre, the Founder-Principal of the pioneering Bharata College of Fine Arts & Culture and Artistic Director of Kala Paricchaya, Mumbai.

Dr Purecha is an internationally renowned scholar and performer of Bharatanatyam, having authored seven research-based books and given innovative presentations of shastra and sampradaya, including performing all the 324 verses of the Abhinaya Darpanam in an audio-visual form. An authority on classical dance and Sanskrit, she is affiliated to several universities. She has been invited as a scholar to universities and for international seminars, conferences like International Conference on Natyashastra, IGNCA- Varanasi to name a few and has delivered illustrative talks on dance to a diversified audience. Prof Pant has been a Visiting Professor at the Indian Institute of Management, Bangalore; a Visiting Professor at Banaras Hindu University, Varanasi; a Visiting Fellow at the Center for the Advanced Study of India, University of Pennsylvania; a Visiting Scholar at the Center for International Peace and Security Studies, McGill University; a Non-Resident Fellow with the Wadhwani Chair in US-India Policy Studies at the Center for Strategic and International Studies, Washington, DC; and an Emerging Leaders Fellow at the Australia-India Institute, University of Melbourne.

Prof Pant's current research is focused on Asian security issues. His most recent books include India and Global Governance: A Rising Power and Its Discontents (Routledge) and, Politics and Geopolitics: Decoding India's Neighbourhood Challenge (Rupa) amongst others. Prof Pant writes regularly for various Indian and international media outlets including the Japan Times, the Wall Street Journal, the National (UAE), the Hindustan Times, and the Telegraph.

Mr Rohan Jaitley is a lawyer based in Delhi. He was selected for Commonwealth fellowship to carry out research work in the United Kingdom. He also received Junior Research Fellowship from Indian Council of Medical Research (ICMR). He also qualified UGC-CSIR NET examination and received Senior Research Fellowship from the Council of Scientific and Industrial Research (CSIR), Government of India. He joined Civil Service in July, 1988 and received training at LBSNAA, Mussoorie and IGNFA, Dehradun.

Provost of Amrita Vishwa Vidyapeetham, Dean of International Programs and UNESCO Chair on Experiential Learning for Sustainable Innovation and Development, India



Dr Maneesha has done pioneering work in the area of Climate Action (SDG 13) with respect to landslide disaster management, disaster resilence including flood evacuation. Her work has encompassed the OceanNet project which addresses the marine internet challenges faced by the fishing populace along the southern coast of India. Her work on Clean water and Sanitation (SDG 6), included 'Jivamritam', a purified clean drinking water initiative, found solutions in more than 5,000 Indian villages to provide clean drinking water to over 10 million people. She is an inventor of low power wireless Remote ECG wearable devices and invented a revolutionary new communication network for fishermen, that can be used by them, upto a distance of 120 KM when at sea.

Over 2019 to 2021, Stanford University, USA has ranked Dr. Maneesha, as one among the global top 2% scientists in the Networking & Telecommunication field, for the quality of her research. She has combined interdisciplinary domains of internet of things, meteorology, hydrology, geology and data science to build world's first Al integrated IoT based landslide early warning system.

Krishna S. Vatsa has worked in the area of disaster risk reduction and recovery for the last 25 years.
