#### In this Edition

The controversy regarding the appointment of a care taker government in Gilgit Baltistan refused to die down. There was uproar when the federal minister for Kashmir Affairs and Gilgit Baltistan, Muhammad Barjees Tahir, was appointed as the Governor of the region. Subsequently, the appointment of a former banker, Sher Jahan Mir as the care taker chief minister, also, was widely resented. There were widespread allegations that the caretaker chief minister was politically inclined towards the PML-N (Pakistan Muslim League-Nawaz). Interestingly, the Empowerment and Self Governance Package 2009 did not have any provision for a caretaker government after the term of the incumbent government expires. Certain amendments were initiated by the government of Pakistan to accommodate setting up a caretaker government in the region as the elections could not be held on time after the previous PPP (Pakistan Peoples Party) led government completed its five year term in December 2014. After the caretaker government took oath, there were sections who objected to the set up as being not fully representative of all sub regions of Gilgit Baltistan. They alleged that regions like Hunza, Ghizer and Ghanche had no representation in the care taker government.

A meeting was scheduled between the Cross LoC (Line of Control) traders of Jammu and Kashmir and the so called Azad Jammu and Kashmir at the Kaman Bridge in the middle of January 2015. Such meetings between the traders from both sides have been held in past. This time around the traders made a request that a meeting be held so that they could discuss issues related to zero tariff and barter trade and the common problems which they face while trading across the LoC.

The fiscal deficit in the so called AJK government's budget is reportedly widening and has crossed over Rs 14 billion, as noted in one of the reports included in the current issue. Due to this deficit, the AJK government noted its difficulty in compensating the victims of the colossal floods that occurred in the year 2014.

# Shabbir Mir, "Collateral damage: Local communities call for renaming of Bunji power project"

People from various parts of Baltistan held a protest in Skardu on January 1 to urge the government to rename the proposed Bunji Dam hydropower project. Protesters demanded the project be renamed 'Bunji-Rundu Dam' as a large number of people from Rundu area of Baltistan will be displaced once construction work begins. More importantly, the dam includes a large part of Rundu area and its name should reflect this, they added. According to the protesters, the change of name will ensure the sacrifices of the Rundu communities are not forgotten and they are not deprived of their rights.

Speaking about the environmental impact of the project, they stated the dam will submerge nearly 50 kilometres of land in Rundu and displace over 28,000 people. The protesters threatened to obstruct the construction of the dam if their demands are not met. When it was first proposed, the Bunji power project was expected to be completed within six years at an estimated cost of Rs12 billion. A survey conducted by the Environmental Protection Agency in August 2013 claimed the lower part of Shangus area would be submerged because of the project. However, the survey confirmed displacement will be far less compared to that feared in the Diamer-Bhasha hydropower project. Nevertheless, residents voiced concerns that the construction of the dam will affect their livelihood. They also insisted that the existing survey did not reflect everything at stake and demanded it be conducted once again.

"For the record: 'G-B governor not target of

#### bomb'"

Ghizer DC Rai Manzoor on January 3 cast aside speculation about Gilgit-Baltistan (G-B) Governor Pir Karam Ali Shah being the target of an improvised explosive device (IED) planted along a roadside in the district a day earlier. The bomb disposal unit (BDU) defused an eight-kilogramme bomb fitted inside a water cooler in Sipli. The cooler was placed along a road leading to the governor's residence. Manzoor, however, stated the bomb was not connected to a wireless remote and hence the governor's motorcade which frequents the route was an unlikely target of the terror bid. Police reached the spot at 8am on January 2. The road remained cordoned off until the BDU defused the explosive at around 12:30pm. A security official privy to the investigation stated miscreants were probably transporting the bomb elsewhere, but left it on the deserted road due to heightened security at checkpoints. A case has been registered with Ghizer police and further investigation is under way.

### Senge Sering, "Terror Outfits Build Presence in Gilgit-Baltistan"

Khalid Balti, a resident of Gilgit-Baltistan, has been chosen as the new spokesperson of Pakistan's Taliban (TTP). He was selected to replace Shahidullah Shahid, who left to join the Pakistan based affiliates of the Islamic State in Iraq and Levant (ISIS). Naming a local is evidence of the Taliban's growing interest in the strategically

located Gilgit-Baltistan region. Khalid Balti, who identifies himself as Mohammad Al-Khorasani, was born in Thogmus Village in the Gangche district in Gilgit-Baltistan. He left for Karachi in 1994 after studying at a local religious school. Balti is considered a religious scholar whose previous affiliations with several madrassas in Karachi include Jamiat-ul-Rasheed, Jamia Banoria, and Jamia Farooqia. His expertise in publishing and association with the Taliban's Umer media led to his prominence and his appointment is a diplomatic move by the Taliban to use cultural competency to fortify their stronghold in a disputed region that is claimed by both India and Pakistan.

Moving forward, it is expected that his understanding of local sectarian dynamics between Shia, Sunni, and Sufi Nurbakhshia will serve in recruitment efforts killing dozens, including local minorities, military officials, and tourists. The group has also attacked and bombed local girls' schools to show its opposition to female education. Like the Taliban, ISIS also stands to gain in Gilgit-Baltistan, a potential point of convergence between affiliated militant groups from Central Asia, Afghanistan, Xinjiang, Kashmir, and Pakistan. The rugged mountainous terrain and sparse population of Gilgit-Baltistan is conducive to the staging of militant forays into India, which the plains of Punjab lack. The Taliban and ISIS stand to benefit from an existing terror infrastructure and residual local sympathy for the Kashmiri and Afghan mujahideen. Despite opposition from local Shias, Pakistan employed religious extremism as a tactic to counter Indian control in Kashmir which led to militants from across the nation rushing in to establish training camps and seminaries in Gilgit-Baltistan.

### Abbottabad Civil Judge Issues Arrest Warrant of Mir Shakeel ur Rehman

#### Pakistan Tribe, January 7, 2015

Civil judge Najeebul Haq of Abbottabad Civil Court issued warrants for arrest of GEO News owner Mir Shakilur Rehman, anchor Shaista Lodhi, actress Veena Malik and her husband Asad Malik.

over their repeated absence from hearings of a blasphemy case. Civil judge, Najeebul Haq, expressed his displeasure over repeated absence of Jang/Geo group owner Mir Shakil ur Rehman, Mir Ibrahim, Shaista Lodhi, Veena Malik and Asad Khattak. The court issued 'permanent' arrest warrants for the accused and ordered police to ensure their arrest and production in the court. The hearing was adjourned till January 15. Earlier, after receiving the jail term by Anti-Terrorist Court (ATC) of Gilgit-Baltistan, a petitioner moved the Supreme Court of Pakistan to drag owner of Geo/Jang Group via International Police aka Interpol. Pakistan Tribe's court correspondent reported that a petitioner filed a petition in the highest apex court to take action against Mir Shakeel ur Rehman.

One Mehmood Akhter Naqvi submitted a petition stating that ATC Gilgit-Balistan sentenced Mir Shakeel and others accused to 26 years imprisonment and a fine of Rs 1.3 million but he mustered help and absconded. It was, therefore, demanded to bring him and other absconders back to the country. He further suggested cancelling Mir Shakeel's license for the newspaper and channel. Federation, Secretary Information, Prime Minister, Mir Shakeel ur Rehman, Shaista Lodhi, Veena Malik and other were declared parties to the case.

My native district Ghizer, one of the seven districts of Gilgit-Baltistan, has many peculiarities. First of all, it is known as the district of the 'martyrs' because its youth have made significant contribution to the Pakistan Army. Secondly, it is famous in Pakistan for being one of the most peaceful areas as no sectarian or militant-related activity has ever been reported even during the three-decade-long sectarian conflict in other parts of Gilgit-Baltistan.

The district, with a 95 per cent population of Ismaili Muslims, has a track record of living in a peaceful way with the people of other sects. The advent of

2015 was somehow alarming for the locals in Ghizer due to the discovery of a 12-kilogramme homemade bomb which was defused by the police in the Silpy village, just one kilometre away from the district headquarters Ghakuch, after being informed by a local on January 3. Experts believe that it would have had a devastating effect had it exploded before being defused. Some reports suggest that it was planted to target the governor of Gilgit-Baltistan, Pir Karam Ali Shah, who is otherwise an uncontroversial figure of G-B in the eyes of all the sects.

# Shabbir Mir, "Save the river: Municipal administration officials dump waste into Gilgit River"

Gilgit River became a breeding ground for pollution after a group of low-grade officials of the municipal administration started disposing waste by it. According to insiders, the officials began dumping waste near the Reinforced Concrete (RCC) Bridge in Konodas. This has negatively impacted the scenic beauty of the river and contaminated the water for people living downstream. A heap of waste was first noticed in the river by Abdul Rahman Bukhari and Essa Haleem, two Gilgit-based journalists.

They immediately lodged a complaint with the police and urged them to take action against the perpetrators. Following the complaint, SHO Murtaza Shah summoned Javed Iqbal, chief officer of the municipal administration, to the police station for further interrogation on January 7. However, Iqbal denied that the municipal administration was involved in this practice and vowed to investigate the matter. It was later revealed that some low-grade officials of the municipal administration had been dumping waste on the request of a resident of Haider Pura who needed help 'levelling his land'.

Gilgit-Baltistan, known for its scenic beauty, present an irony. A majority of the residents of the region live a life of poverty marred by illiteracy in an underdeveloped set-up. To help the people of the northern areas, Pakistan Air Force (PAF) in collaboration with Civil Aviation Authority (CAA) has begun an initiative to educate and train underprivileged children of underdeveloped and far-flung areas, especially in Pakistan's north, in order to promote education and sports activities. PAF initiated two programmes in this respect three years back-Free Education and Training (FET) and Volunteer Programme in Gilgit-Baltistan. In the volunteer programme, educated individuals are selected from various walks of life from throughout Pakistan. Recently, PAF has begun running these programs in Naltar, a valley at an hour's drive from Gilgit. The children are being provided free books. Computer labs have been set up and salaries are being given to local teachers. PAF is also training skiers in the area with the help of the Ski Federation of Pakistan (SFP). SFP spokesperson Obaid Abbasi noted that different governments floated different ideas to deal with the situation but in vain.

### "GB hospitals to get Rs1.5 billion for machinery"

The Planning Commission of Pakistan has approved Rs1.5 billion for the purchase of modern machinery for government hospitals in Gilgit-Baltistan. The money to be provided by the Islamic Bank will be given to the region's health department, an official of the Gilgit chief sectary office noted on January 8. The official noted that the Planning Commission had approved the amount of money during a recent meeting of the Central Development Working Committee in Islamabad. He stated a request for the money was sent to the Planning Commission by the GB Development Working Party three months ago. The official stated the

money would be used to buy modern machinery for district headquarters hospitals of Skardu, Gilgit and Chilas. He further stated the installation of modern machinery would improve patient care at the region's hospitals. Visitors, mostly the poor people, complain facilities at government hospitals in the region are very poor to their misery.

### Abdul Manan, "PM gives nod for establishment of military courts in Gilgit-Baltistan"

Prime Minister Nawaz Sharif on January 13 gave a nod for the establishment of military courts in Gilgit-Baltistan. The premier approved that Gilgit-Baltistan and AJK Councils also adopt the 21st Constitutional Amendment as well as amendment in the Army Act to facilitate formation of military courts in those areas. Presiding over a meeting to review progress on the National Action Plan (NAP), the prime minister stated, "there is no room for terrorism or terrorists in our society." The Prime Minister was briefed on legislative and administrative measures as well as the progress on sub-committees regarding implementation of the National Action Plan. We have the determination not to be at ease till the elimination of every last terrorist from our country," Nawaz added. The meeting further reviewed progress on legislative measures, administrative measures and progress on sub-committees, according to an official statement.

During the meeting, the premier was informed that since December 23, 2014 in Punjab and Islamabad Capital Territory, 164 cases have been registered for use of hate speech and material while 157 persons have been arrested. Further, 40 printing presses and shops have also been sealed. On the misuse of loudspeakers, 1,994 cases have been registered and 1,088 persons have been arrested. Information from other provinces is awaited. The prime minister is personally supervising progress on the speedy implementation of the NAP.

# Fazal Sher, "NJHP hydel project: AJK government urges Centre to provide its share from profit"

The Azad Jammu and Kashmir (AJK) government on January 13 urged the federal government to provide its share from the net hydel profit of Neelum Jhelum Hydroelectric Project (NJHP). Officials of AJK government while speaking at the Standing Committee on Kashmir Affairs and Gilgit-Baltistan stated the federal government need to provide share of net hydel profit generated from Neelum-Jhelum Hydroelectric Projects like Khyber Pakhtunkhawa is getting in the case of Tarbela dam. They stated that we just want parity and what the government has provided to other province should also be provided to AJK. General Zubair (Retd), Project Director, Neelum-Jhelum Hydropower project, told the committee that the cheap power generation project will be completed by December 2016. He stated the total foreign currency component (FCC) requirement of the project as per approved PC-1 is \$1.585 billion. The donors of the project had agreed to provide \$1.110 billion against provision of PC-1 for FCC, which is \$1.585 billion, a gap of \$475 million still exits for which the government of Pakistan is exploring new avenues, he stated.

The project director further stated that one Chinese engineer along with three Pakistani workers died in an accident on December 24. The Chinese companies have admitted that it was fault of the company and the workers would be compensated and will be given Rs 0.5 million per workers. The members of the committee also expressed concern over the amount of compensation and urged the official to direct the Chinese company to pay compensation to the victim families according to international rules. Chief Secretary AJK informed the meeting regarding rehabilitation activities carried out after the severe floods in different areas of AJK. Due to the flood, 56 people have lost their lives and 46,979 people rendered homeless. The committee also recommended initiation of flood mitigation projects in AJK to avoid such huge losses in future.

# Parvez Jabri, "Rs29,551.80mn spent on Diamer-Basha dam construction in last five years: NA told"

A total of Rs29,551.80 million have so far been spent on the construction of basic infrastructure of Diamer-Bhasha dam from 2009 to December 2014, State Minister for Water and Power Chaudhry Abid Sher Ali told National Assembly on January 15. Responding to the question by Khalida Mansoor, he stated the United States has agreed to fund the project. However the government will construct the project on its own if funding is not available. The construction of infrastructure/preliminary works of the project colony at Thor Valley and Composite Model Village II at Harpan Das at Karakarom Highway is in process. He stated the construction of main dam has not yet stated due to non-availability of financing arrangements from International Donor Agencies. A sum of Rs337.89 million had been spent on basic infrastructure of Diamer-Bhasha dam during 2009-10. Rs3,534.38 million were spent in 2010-11, Rs4,788.07 million in 2011-12, Rs2,143.41 million in 2012-13, Rs7,774.53 million during 2013-14, Rs8,451 million in 2014-15 and Rs973.49 million were spent on construction of dam's infrastructure in 2014-15.

### Anirban Bhaumik, "Kerry ignores India, brags of backing Pak's PoK dam"

Disregarding New Delhi's sensitivity, United States Secretary of State John Kerry has bragged about Washington's support to Islamabad in mobilising funds to construct a hydroelectric and irrigation project in Pakistan occupied Kashmir (PoK). Kerry told journalists in Islamabad that Washington in October 2014 introduced the Diamer-Bhasha dam project to US investors to encourage them to invest in construction of the hydroelectric plant-cumirrigation facility.

He made this remark while addressing a newsconference jointly with Sartaj Aziz, National Security and Foreign Affairs adviser to Pakistan Prime Minister M Nawaz Sharif on January 13.

New Delhi is understood to be upset over Kerry's remarks. India has since long been objecting to the controversial Diamer-Bhasha dam project since it is proposed to come up at Gilgit-Baltistan in Pakistanoccupied Kashmir (PoK). The US support to Pakistan on the Diamer-Bhasha project has emerged as a new irritant in New Delhi's ties with Washington ahead of American President Barack Obama's visit to India. The joint statement issued after Kerry and Aziz chaired the US-Pakistan Strategic Dialogue on January 13 also expressed "satisfaction" of both as the US Agency for International Development and the US Chamber of Commerce on October 8 last convened the Diamer-Bhasha Dam Project Business Opportunities conference. Kerry met Aziz in Islamabad and made the remark just two days after calling on Prime Minister Narendra Modi at Gandhinagar on the sideline of the "Vibrant Gujarat Global Investors' Summit".

### "Earthquake-hit areas: Erra approves final strategy for completion of 1000 schools"

Earthquake, Reconstruction and Rehabilitation Authority (ERRA) approved a final strategy for the completion of 1000 schools by the end of December 2015 in three phases with a cost of Rs 8 billion in the earthquake affected areas. The strategy was approved on January 13 in monthly review meeting of the authority which was chaired by Deputy Chairman ERRA, Major General Muhammad Azeem Asif. The meeting was attended by the outgoing and incoming Chief of Staffs ERRA, Director General Pakhtunkhwa Reconstruction, Rehabilitation Authority, State Earthquake Reconstruction, Rehabilitation Authority and other senior officials. While giving the details of schools construction plan, DG planning Tahir Pervaiz Dar stated that by March 2015, total 200 schools are planned to be completed and ready for inauguration by the Prime Minister Muhammad Nawaz Sharif. He added that 100 school each will be completed in earthquake affected areas of KPK and Azad Jammu and Kashmir depending on availability of funds by the federal government.

### Muhammad Saleh Zaafir, "Military courts to be set up in AJK, GB"

A high-level meeting to review the National Action Plan (NAP) to counter terrorism on January 13 decided to establish military courts in Gilgit-Baltistan and Azad Jammu and Kashmir. The meeting chaired by Prime Minister Nawaz Sharif was held at the PM House. Prime Minister Nawaz Sharif while addressing the meeting made it clear that the government would not rest till the elimination of terrorism from the country since any let-up in this regard would be tantamount to criminal negligence. He stated there was no place for terrorists in the country. The meeting is significant in the backdrop of the revelation by Interior Minister Chaudhry Nisar Ali Khan a day earlier about the lethargic attitude of the provinces in the implementation of NAP except Punjab and lack of their coordination for the purpose. The meeting was also attended by the interior minister who briefed it regarding progress on the implementation of the plan. The meeting decided that the Gilgit-Baltistan and AJK councils would also adopt the 21st constitutional amendment as well as the amendment in the Army Act 1952 to facilitate formation of military courts in these areas.

### Shabbir Mir, "Now or never: Lawyers urge government to end G-B's constitutional limbo"

Lawyers in Gilgit-Baltistan (G-B) urged the federal government to either bring the region within the purview of Pakistan's constitution or provide it with a separate constitution. The firm stance comes at a time when the region is preparing for elections this year. A caretaker set-up has already been put in place with a mandate to hold elections within 90 days after the Pakistan Peoples Party (PPP)-led

government completed its five-year term in December 2014. "This is the right time to grant us a constitution and redress the sense of deprivation which the region has faced for decades," G-B Bar Council Vice President Shehbaz Khan noted on January 7. According to Khan, the G-B Self Governance and Empowerment Order 2009 introduced by the erstwhile PPP government is inadequate to suit their needs. "The 2009 order will not be accepted anymore," he added. "Instead of introducing ceremonial changes in the order, the federal government should make arrangements to conduct elections for a constituent assembly". G-B was made a de facto province through a presidential order in 2009. While the semi-autonomous region has its own chief minister and governor, its people don't have representation in the National Assembly.

A high level meeting on implementation of National Action Plan (NAP) against terrorism has decided that Gilgit-Baltistan and AJK Councils would also adopt the 21st Constitutional Amendment with amendment in the Army Act to facilitate formation of military courts in these areas. The Prime Minister, who chaired the meeting, reiterated his resolve against terrorism and extremism. An official stated that heads of different sub-committees have briefed the Prime Minister about progress on implementation of NAP. An official further stated that the Attorney General for Pakistan briefed the Prime Minister on legislative measures while other concerned updated the meeting on administrative measures. The Prime Minister has formed 15 subcommittees for implementation of the NAP and set a timeframe to submit their recommendations. He himself is heading the principal committee on implementation of a counter-terrorism plan. The meeting was informed that since December 23, about 164 cases have been registered in Punjab and Islamabad capital territory for use of hate speech and material while 157 persons have been arrested.

Some of the religio-political parties in Gilgit-Baltistan (G-B) are demanding the annulment of the provincial caretaker cabinet for being nonrepresentative, biased and unbalanced. These assertions may be true, but if the demand to change the already notified caretaker provincial cabinet is acceded to, it will cause religio-political rifts in the region. The parties which have reservations about the mechanism used for the selection of the cabinet members must tolerate this for now and remain silent for the greater cause of peace in the region. Of course, it goes without saying that the incumbent government in Islamabad is completely disconnected from the indigenous dynamics of G-B. While the people objected to the previous provincial government of the PPP for being corrupt and incompetent, it is also a fact that the party has actually given a lot to G-B. Zulfikar Ali Bhutto, in 1972, visited the region and set the people free from the clutches of the Rajgi system. It should be clear that I am neither a PPP supporter nor do I have any kind of affiliation with that party and nor do I support everything that the PPP has done in the rest of the country. But it is a fact that Bhutto annulled the extension of the Frontier Crimes Regulation and empowered this region through the Northern Areas Legislative Assembly. Later on, in 2009, the PPP, once again, empowered the region through the Gilgit-Baltistan Self-governance Ordinance, 2009 and granted 'provincial status' to the region and also gave it an identity and name of 'Gilgit-Baltistan' instead of the previously used nomenclature of Northern Areas.In stark contrast, the PML-N, which ruled the country for three terms, did nothing for the betterment and progress of G-B. Admittedly, G-B is indeed a very difficult area to administer.

#### "Editorial: Logging and consequences"

Forest cover in Gilgit-Baltistan (G-B) has diminished by more than 50 per cent in the last 20 years, and the rate of deforestation is unlikely to

slacken. The felling of banned species such as pine, kail and deodar continues; and despite being aware of this, the present government has lifted a logging ban that it itself had imposed shortly after coming to power. The lifting of the ban is likely to have farreaching environmental consequences, not the least of these being the erosion of critical slopes and the consequent landslips often with disastrous consequences for mountain communities sited below the slide areas. There is an almost insatiable demand for good quality wood in Pakistan, not just for fuel in remote and rural areas, but as building material. Technically, the land that is being logged belongs to local communities in Diamer district of G-B under a deal they signed with the thengovernment in the 1950s; but the reality is that logging is controlled by the G-B Council (chaired by the prime minister) and the timber traders. The tussle between the commercial imperatives of the loggers and the preservation concerns of the environmentalists is long and bitter.

The pendulum has swung to and fro with a ban imposed in 1993 only to be lifted by the Musharraf regime in 2000. Logging continued recklessly until 2008 when restrictions were again imposed but the forest department did little to implement it and we now arrive at a situation that borders on the environmentally catastrophic. Forests thus stripped in a mountain landscape are slow to regenerate, likewise undergrowth that has been ravaged by unrestricted grazing of goats (to a degree reversed in recent years), and unless there is a brake put on illegal logging, irreversible damage may soon be caused. A meeting in Chilas on January 27 aimed at reviving the 'Zaito' committees, which are designed to enable communities to protect forests under their purview, may stem the tide; but there is big money to be made in the timber trade. Trees are set for an uncertain future.

### "Let the polls begin: 'G-B elections scheduled for May'"

Around 50 days after the Pakistan Peoples Party-led Gilgit-Baltistan (G-B) government completed its five-year term, elections for the legislative assembly have been announced for May 2015. "It has been decided and a notification to this effect was also issued," G-B and Kashmir Affairs Federal Secretary Shahidullah Baig told Outpost, a local publication. A competent local has been appointed as the chief election commissioner, Baig added. Last week, a 12-member caretaker cabinet took oath in Islamabad and promised free and fair polls. "Better late than never; it will help remove misconceptions over the government's intentions," stated a political figure while commenting on the delay in the announcement for polls. According to

reports, portfolios were assigned to caretaker cabinet members, but the appointments are still awaiting notification. Following several postponements, members of the G-B Council representing the region have decided to boycott council meetings chaired by the prime minister. They demanded either constitutional powers through the 18th Amendment or to be made part of the NFC Award. The demands were forwarded by members of the G-B Council on January 28just a day after the meeting was postponed for the fifth time since November 2014. Six of the council's 12 members are from G-B council, while the rest represent the federal government.

As pressure over cabinet appointments mounts, the federal government has decided to include five more members in the caretaker set-up of GilgitBaltistan (G-B). The appointments, if confirmed, will double the strength of the interim cabinet to 10 members and help settle differences between Gilgit and the Centre. Last week, the Centre appointed five membersInayatullah Shumali, Sheikh Nasir Zamani, Advocate Mushtaq Ahmed, Niamatullah and Sanaullahin the caretaker set-up that took charge in December 2014 after G-B's elected government completed its five-year term. The initial decision to appoint just five cabinet members triggered region-wide protests as three districts, including Hunza-Nagar, Ghizer and Ghanche, lacked representation.

The exclusion forced the interim chief minister to admit he was not consulted in the formation of the cabinet. In a bid to settle the issue, the G-B-chapter of the Pakistan Muslim League-Nawaz (PML-N) held a parliamentary board meeting in Islamabad. The regional chief of the party flew in to Islamabad to take part in the meeting. "It was decided that five more members would be appointed in the cabinet from the areas ignored earlier," a politician who attended the meeting noted on January 20 while referring to Hunza-Nagar, Ghizer and Ghanche districts. He stated others being considered as cabinet members were Kalbe Ali from Hunza-Nagar district, Fozia Kulsoom from Skardu, Abdul Hanan from Ghizer, Fida Zaidi from Ghanche and Basharatullah from Diamer. However, they have not yet been made members as the summary for their appointment sent to the prime minister has not been signed yet. The meeting also decided to hold elections in May/June when weather conditions improved, he added.

### "828 Afghan families deported from Azad Kashmir"

### Mushtaq Ghumman, "AJK decides to rebid power project"

The Azad Jammu and Kashmir (AJ&K) government decided to offer 48 MW Jagran-II hydropower project for rebidding after a

controversy emerged in the award of the project. Chaudhry Yasin, Minister for Irrigation, AJ&K, who is also head of the AJK hydroelectric board noted that he took this decision at a meeting of the board to ensure transparency in the award of this important project. The French agency, Agence Française de Development (AFD), has earmarked Euro 68 million for the project and one million Euros for engineering services. The world's biggest Chinese company in hydropower generation, Sinohydro, which was the lowest bidder through its local representative, wrote a letter to the Prime Minister's Office for intervention accusing the Azad Jammu and Kashmir Electric Board (AJK-HEB) of accepting the second lowest bid by another Chinese company, CWE. He stated, Sinohydro offered to do the job for Rs 6.9 billion while CWE demanded Rs 7.4 billion. The letter written to the Prime Minister's Office by Sino hydro's representative stated that at the tender opening on September 23, 2013, the read out price of Sinohydro and its local partner was the lowest. During the bid evaluation period, not a single clarification was sought from them with respect to any deficiency in the bid. The letter stated that the LHC set aside blacklisting of Sino hydro's partner by the Punjab government on February 13, 2014. It added that the judicial order removed the ground on which the evaluation committee decided to exclude the lowest price bid.

#### "AJK govt budget deficit crosses Rs 14b"

The Azad Jammu and Kashmir government is in severe financial crunch as its budgetary deficit has crossed Rs 14 billion and it has expressed its inability to pay compensation to the affectees of 2014 devastating rains and floods. According to reports, the AJK government had requested the federal government to provide a grant of over Rs 1.15 billion but so far has not received any response. The finance ministry advised the AJK government to check its non-development expenditure. Reports stated that the AJK secretary finance in a letter to the federal ministry informed it about financial crisis and sought supplementary grant for payment of compensation. It stated that during the first quarter of the financial year the difference between income and expenditure was around Rs 6 billion which has now crossed to Rs 14 billion. "The loan is repayable in 20 years at two per cent charge with five years grace period," Jassim M Al-Khaldi, Charge d'affaires, Embassy of Saudi Arabia informed Finance Minister, Ishaq Dar on January 7. "Jassim Al-Khaldi handed over a letter from the Saudi Finance Minister to Ishaq Dar, conveying information about Saudi loan of 206 million Riyal for Chehlla Bandi road project near Muzaffarabad," noted a statement issued by the ministry of finance. Commenting on 'Zarb-e-Azb' operation, Jassim shared his county's strong feelings for Pakistan on countering terrorism.

Acknowledging the Saudi support, the Dar thanked the Saudi government for its support to Pakistan. The minister also briefed the Saudi Envoy about the ongoing operation 'Zarb-e-Azb'. He stated the Pakistani nation, in unison with the armed forces, has a resolve to carry this operation to a conclusion. He stated that the war on terror had taken a heavy toll on Pakistan's economy and the overall losses had already surpassed 100 billion dollars. A large number of people were displaced due to the ongoing operation and hefty resources were needed for rehabilitation of the displaced persons. The minister also inquired after the health of King Abdullah and conveyed warm sentiments of the government and people of Pakistan for Khadim Al-Haramain Al-Sharifain.

### "IFC/WB okay financing 108MW Gulpur Hydropower Project"

International Finance Corporation (IFC)/World Bank (WB) Board has accorded approval for financing 108 megawatts (MW) Gulpur Hydropower Project located at Poonch River district Kotli Azad Jammu and Kashmir (AJK). A high level delegation of IFC/WB meeting with Finance Minister Ishaq Dar discussed in depth various WB sponsored development projects. Dar lauded WB Board's decision regarding Gulpur Power project as government was making efforts to generate affordable energy to meet the future requirements. He appreciated WB's continued support for different projects specially 4,200 mw Dasu Hydropower Project that would greatly help alleviate the energy problem. Dar stated Pakistan had become eligible for IBRD economic package after achieving \$15 billion forex reserves mark and there would be further expansion in WB's project funding in Pakistan, Finance Ministry noted in a statement. The statement stated another WB team had a meeting with senior officials of the Finance Ministry. During the meeting the performance of National Income Support Programme (NISP) was discussed. The delegation expressed satisfaction on improved NISP performance. The delegation hoped with increased funding NISP would better reach out to poor segment of the population.

### "Raising a voice: Diaspora demands right to vote in upcoming elections"

Baltistan residing outside the region have demanded voting rights. "A large proportion of G-B's population is living outside of G-B because of lack of educational and employment opportunities. Not including them in the election process will be tantamount to denying them their basic rights," reads an online petition initiated by Ali Taj, who lives outside G-B. "The general elections for Gilgit-Baltistan's Legislative Assembly are around the corner," the petition states, adding nomination of chief election commissioner and interim set-up has been finalised and both bodies will start initiating the poll process soon. According to the petition, because of the long distance, many people will not be able to reach G-B to vote in the upcoming elections. It demanded the election commission and interim government take necessary steps to allow the diaspora of G-B to vote in the polls. "Voters should be given the facility of postal service or polling stations should be set up at the office of district coordination officers in major cities," states the petition. While the schedule is yet to be announced, it is generally believed elections for G-B's legislative assembly will take place in June 2015. Although there are no exact figures available of the number of people residing outside of G-B, it is stated to be in the thousands.

### "Power cuts: Traders, residents take to the streets"

Traders and civil society members in Azad Jammu and Kashmir (AJK) staged a protest in the capital city over the weekend against what they termed unannounced power cuts in the area. Traders' Joint Action Committee President Razag Khan stated around 1,200 megawatts (MW) of electricity was being produced from AJK but the Water and Power Development Authority (Wapda) had failed to provide the minimum 300MW to local residents who sacrificed their graveyards to construct the Mangla Dam. He stated that 10 to 12 hours' of loadshedding had adversely affected businesses and daily activities. The protesters gave January 9 as a deadline to Wapda to solve the issue otherwise they stated they will be compelled to take extreme steps to get their rights. Later, the traders also set up a protest camp outside the Central Press Club, which was visited by leaders of various political parties. The Pakistan Muslim League-Nawaz is the opposition party in the AJK Legislative Assembly.
