In this edition, a great deal of focus has been laid on the controversial Diamer Bhasha dam situated in Gilgit Baltistan. The Asian Development Bank (ADB) which is supposed to lead the funding consortium held intense discussions with the WAPDA(Water and Power Development Authority) raising several pertinent pending issues such resettlement of displaced population, the resolution of the boundary dispute between Gilgit Baltistan and Khyber Pakhtunkhwa etc. There were reports noting the ADB was initially reluctant to engage in the Diamer Bhasha project due to these problems. However, it later agreed to provide technical and financial supports to the project even though the agreement between ADB and the WAPDA is yet to be formalised in the form of an MoU.

China too has reportedly agreed to give \$ 4 billion towards the Diamer Bhasha project. The assistance would include financing of several components in the massive hydel project as stated in one of the reports included in the issue.

India has raised objections to the external financing of a dam which is located in a territory under Pakistan's unlawful control. Since objections in the past have failed to deter multilateral institutions such as the ADB and China to involve in a controversial project in PoK, India needs to make its stance on the issue more pronounced. And this is possible only if a more forthright and robust policy on PoK is formulated especially keeping in view recent developments across LoC.

Shahbaz Rana, Diamer-Bhasha Dam: ADB asks govt to focus on people, not just water, power

ISLAMABAD: While Pakistan frets over megawatts generated and million acre feet of water stored, the lead financier of the Diamer-Bhasha Dam says the country should focus on social aspects of the affected population and address issues of environmental degradation and revenue sharing between contesting territories.

With an estimated price tag of \$11.2 billion, the project is planned to be completed in 12 years. It will generate 4,500 megawatts of electricity, besides storing 8.5 million-acre-feet of water for agriculture purposes. Satisfactory resettlement "Pakistan has not been focusing on social aspects of

the project as much as one could hope,” stated Rune Stroem, the Asian Development Bank's (ADB) Head of Energy Division on December 13.

Javaid Hayat, Empowering Azad Kashmir

Nation-states are recognized by the international community as sovereign states as per the 'Westphalian sovereignty' concept. Notwithstanding, there are political entities on the world map, which are mostly driven by conflict or crisis and disputed or tangibly controlled by external powers. The Azad state of Jammu & Kashmir (AJK) is one of them. Defining AJK in a legal and constitutional context under United Nations Commission for India and Pakistan (UNCIP) resolutions on Kashmir and in international relations remain a dilemma. At the time of the formation of the Republic of Azad Kashmir on 24 October, which intended a transition from autocracy to democracy, the provisional government of Azad Kashmir made a declaration that “The new government represents the united will of Jammu and Kashmir State. The provisional government entertains sentiments of the utmost friendliness and goodwill towards its neighbouring dominions of India and Pakistan and hopes that both the dominions will sympathise with the people of Jammu and Kashmir in their efforts to exercise their birth right of political freedom. The provisional government is further anxious to safeguard the identity of Jammu and Kashmir as a political entity”.

Petition, in GB Chief Court, to Challenge Exploration License to Mohsin Industries

The Chief Court of Gilgit-Baltistan has admitted a Writ Petition on December 12 for regular hearing wherein the issuance of Exploration Licenses to Mohsin Industries by the Government of Gilgit-

Baltistan has been challenged; a Press note, released by Sargin Law Associates, stated. The petitioners, M/S Pan Euro International, Bilchar Trade International and Skardu Gems and Minerals, have objected that the issuance of licenses to the Hong Kong based company is 'illegal, unlawful and against national interest'.

The Petitioners charged that Explorations Licenses to Mohsin Industries is an abuse of process, act of discrimination and encroachment on local property rights. The government of Gilgit-Baltistan has ignored several applications submitted by local, national and international companies including those of the petitioners pending for the last three years. While, issuing the licenses to Mohsin Industries, the government has shown extra legal and judicial leniency.

The petitioners charge that in the matter of issuance of the Exploration Licenses, the fundamental rights of the local people granted in the Gilgit-Baltistan Empowerment and Self Governance Order 2009 have been violated. The petitioners also contend that the GB government has betrayed its own Cabinet decision that has sought ban on issuance of exploration licenses and mining leases until further orders.

On June 7th this year, the GB Legislative Assembly has passed a resolution that sought an immediate ban exploration and export of precious mineral resources from the region. But the government continued contravening the GB Rules of Business (2009) too.

The petition pointed out the gross violations of Northern Areas Mining Concession Rules 2003 that, according to the petitioners, has been committed by the Mineral Department of Gilgit Baltistan. The petition further contends that Wang Zunyu's application was processed and approved through extra-ordinary processes despite his application being defective and incomplete. More than 200 other applications, including those of the petitioners, passed through nobody's table.

Sajid Chaudhry, Diامر-Bhasha Dam project: ADB suggests Pak resolve revenue sharing

ISLAMABAD: The Asian Development Bank (ADB), the lead financier of the Diامر-Bhasha Dam on December 13 suggested Pakistan to focus on resolution of revenue sharing issue between Khyber Pakhtunkhwa (KP) and Gilgit Baltistan (GB) as well as affected population and address issues of environment degradation for smooth execution of the mega project.

ADB's Head of Energy Division Rune Stroem while speaking to a select group of journalists along with the ADB's Country Director to Pakistan Werner Liepach after conclusion of his visit to Pakistan aimed at 'critically reviewing the mega project'. He stated, "ADB is fully aware that there will be strong debate on revenue sharing and ADB can give advice but at the end the issue will have to be decided by the Council of Common Interests." The KP government is disputing over the ownership of 18 kilometres long belt with GB government in a bid to get share in income from the power generation. The GB legislative assembly has passed the resolution against the provincial government claim and intends to take the matter to the Supreme Court if it is not amicably resolved.

"Pakistan has not been focusing on social aspects of the project as much as one could hope," Stroem noted and added that the success of the project hangs on local people satisfaction with resettlement activities. "The resettlement work has been done but still there are gaps where the government needs to bring in improvement as per international standards," he added.

Explaining the gaps, Stroem noted individual activities were going on at relatively small scale and lots of pilot projects have been initiated. He further stated that the legal dispute over sharing of revenues between GB and KP has to be worked through and on environment no sufficient work has been done yet.

Zafar Bhutta, Spiralling cost: PM reconstitutes Neelum-Jhelum project board

ISLAMABAD: Prime Minister Yousaf Raza Gilani has reconstituted board of directors of Neelum-Jhelum Hydropower Company, a special purpose vehicle created for executing the project whose cost has escalated to Rs330 billion from Rs130 billion because of delay in work and modification in design after the 2005 earthquake, sources noted. Under the restructuring, chief secretary of Azad Jammu and Kashmir and a representative of the finance ministry have been made board members of the strategic 960-megawatt hydropower project.

The prime minister gave the directives for reconstituting the board during a briefing by the Ministry of Water and Power on the project at the Prime Minister's House on December 12.

Shabbir Mir, Diامر-Bhasha Dam: G-B opposition backs govt over boundary issue

GILGIT: Amid escalating tensions between the two neighbouring regions, the opposition leader in the Gilgit-Baltistan (G-B) Legislative Assembly Janbaz Khan downplayed Khyber-Pakhtunkhwa's (K-P) decision to take the boundary issue to the Supreme Court, asserting that K-P has full rights to move the apex court with documented proof to establish its claim on the Diامر-Bhasha Dam. "It's not a big issue if the boundary dispute is taken to the apex court. We can also go to the Supreme Court to establish our claim on the dam," Janbaz Khan noted on December 12.

His remarks came after the K-P government earlier this week decided to take the Diامر-Bhasha Dam boundary issue to the Supreme Court after G-B's Legislative Assembly last month passed a unanimous resolution against K-P's claim over part of the dam which can displace approximately 22,000 people in 30 villages of the Diامر valley.

Shahbaz Rana, Diamer-Bhasha Dam: ADB agrees to provide technical, financial support

ISLAMABAD: Pakistan and the Asian Development Bank (ADB) have agreed to sign a memorandum of understanding (MoU) for technical and financial cooperation in the

construction of multi-billion-dollar Diamer-Bhasha Dam. The MoU will be inked next week, stated the Ministry of Water and Power after a meeting between Water and Power Minister Naveed Qamar and the Manila-based lending agency's Director of Energy Wing Rune Stroem on December 9.

Stroem is leading a delegation to assess detailed engineering design of the dam, which will store 8.5 million acre feet of water for irrigation purposes and generate 4,500 megawatts of electricity.

Controversial figure: 'Lord Nazir's entry not banned in AJK'

Azad Kashmir, East Turkistan and Gilgit Baltistan: The Unknown Lands

December 8, 2011

BRUSSELS: Hosted by Ms. Kristiina Ojula and Jürgen Creutzmann, Members of the European Parliament, with the support of the Friends of Gilgit Baltistan in the European Parliament and the SADF, the European Parliament debated the situation of Azad Kashmir, East Turkistan and Gilgit Baltistan on December 7.

"Human rights are universal and inviolable and therefore must be secured to the inhabitants of disputed areas," Kristiina Ojulang stated. "The right of self-determination of the people of Azad Kashmir, East Turkistan and Gilgit-Baltistan may neither be ignored by the EU nor the regional major powers." Writer and human rights defender Roy Strider pointed out that Gilgit-Baltistan is being denied even the status of an official province of Pakistan. According to European principles the power games of great countries may not overrun the principles of human rights and self-determination," Roy Strider noted. "The solution would be a referendum on the independence. People must have the possibility to take decisions on their future as well as on the use of mineral and natural resources of their homeland."

Di Amer Bhasha Dam : ADB mission discusses financial plan with Wapda

The Asian Development Bank (ADB) Consultation Mission, headed by the Director Energy Division Rune Stroem, visited Wapda House and had a meeting with Wapda Chairman Shakil Durrani and members of the Authority to discuss the matters relating to financing Di Amer Basha Dam Project. Experts from the USTATED and the project consultants were also present.

In his welcome remarks, the Chairman stated that Wapda is implementing several projects to cope with the increasing demand of water and electricity in the country. Among the projects, he stated, 4500 MW-Di Amer Basha Dam is vital, as this mega project will usher in accelerated socio-economic development in Pakistan. He further stated that Wapda looks forward to a close co-operation of the international financial institutions, the ADB in particular, to implement this mega project.

ADB Director Energy Division, appreciating the progress made so far on Di Amer Basha Dam Project, stated that the technical preparation of the project is quite impressive. Since the project is a major one,

there are challenges as well. The issues relating to resettlement of the affectees and the environment need further study with international consultants.

However, we hope to tackle these challenges in close co-ordination with each other, he added. During the briefing, the ADB Mission was informed that the \$12 billion Di Amer Basha Dam is a multi-purpose project with the objectives to store water for irrigation, mitigate floods and generate low-cost and environment-friendly hydel electricity.

On completion, the project will store 8.1 million-acre feet (MAF) of water besides generating 4500 MW electricity. The project will add about 20 billion units of electricity annually to the national grid. The annual benefits of the project have been estimated at about \$2.3 billion, it was further told. The Mission was informed that a sum of Rs 18 billion has been allocated in PSDP for the project during the current fiscal year.

As many as 1260 acres of land have so far been acquired for construction of Wapda offices, contractor's camp, colonies and infrastructure in the project area. The delegation was also briefed about the resettlement and financial plans of the project.

China to provide \$4b for Di Amer Bhasha dam project

ISLAMABAD: China has assured Pakistan that it will be providing financial assistance up to \$4 billion for 4500 MW Di Amer Bhasha Dam project to be built on Indus River in Di Amer district in Gilgit-Baltistan. An official source stated assistance from China will be in the form of project financing for various components of the \$11.2 billion project. He stated assurance from China has helped expedite the project which will have gross capacity storage of 8.1 million acre feet (MAF) of water.

He stated construction activities of main project will commence from next fiscal year and will take nine years for completion. Government has allocated Rs18 billion for land acquisition during

current fiscal year. Government has also allowed the executing agency, Water and Power Development Authority (WAPDA) to raise funds of Rs20 billion under the government guarantee from market through TFCs or Sukuks. It will be repaid by WAPDA from its own resources.

Zeeshan Javaid, ADB reluctant to fund Diamer-Bhasha Dam project

ISLAMABAD: The Asian Development Bank (ADB) seems reluctant to pledge financial assistance for the billion-dollar Diamer-Bhasha hydropower mega project having generation capacity of 4,500 megawatts (MW), because of loopholes detected in its construction including the disputed area between Khyber Pakhtunkhwa (KP) and Gilgit Baltistan (GB) region of eight kilometres in Diamer village.

A senior official of the Ministry of Water and Power on condition of anonymity informed that Water and Power Development Authority (WAPDA) could not satisfy Asian Development Bank officials, while briefing over Diamer-Bhasha hydropower project with estimated cost of \$12 billion.

The ADB Consultation Mission, headed by the Director Energy Division Rune Stroem met WAPDA Chairman Shakeel Durani on December 7 to discuss matters relating to financing Diamer-Bhasha Dam project accompanied with experts from the United States Assistance for International Development (USAID).

Khalid Mustafa, Power sector to gobble over 2.5pc of GDP this year

December 8, 2011

ISLAMABAD: The economic woes of the cash-starved government have multiplied as the chasm in the power sector -- that sucks 2.5 percent of GDP amounting to Rs300-350 billion every year -- has

become ever wider and deeper on account of the failure to raise power tariff by six percent under monthly fuel adjustment, a senior official at the Finance Ministry noted.

This means that the power sector will now suck more than 2.5 percent of GDP in the current financial year. In just over three years, the power sector has eaten up over Rs1 trillion, which is equal to the cost of the country's biggest future dam, Diamer-Bhasha. The failure to increase the power tariff by 2 percent surcharge from July this year and 4 percent from August this year has exposed the government to an additional loss of Rs24-30 billion so far. Likewise, the government has also been barred by the court from increasing the power tariff under fuel adjustment, which would inflict Rs5 billion per month loss if fuel prices at the world market remains at the existing level.

Funds crunch delaying Neelum-Jhelum project

ISLAMABAD: The Neelum-Jhelum hydropower is facing serious liquidity problem, which has slowed down the pace of construction mainly because of the inordinate delay by China in releasing \$448 million credit. If funds do not come to Pakistan in the next 3-4 months, then the project would be further delayed, a senior official at the ministry of water and power told our sources.

"The Neelum-Jhelum hydropower project is likely to face Rs16 billion deficit this financial year and if the Chinese credit gets materialised it will help cope with the deficit. In the current month alone the project is facing over Rs2 billion deficit." Meanwhile, the official made the alarming disclosure that that India has become active in AJK to kill or abduct the Chinese workers so that the construction work on this vital project could come to a standstill.

Meanwhile, the official made the alarming disclosure that that India has become active in AJK to kill or abduct the Chinese workers so that the construction work on this vital project could come to a standstill. To a question, the official replied that NJHPC needs Rs32.28 billion in the current

financial year against the budgetary allocation of Rs10 billion. In the first 6 months of the current financial, about Rs13 billion have been spent and after that NJHPC is facing the deficit which needs immediate attention of the top authorities. He noted the company spends Rs6 billion collected on electricity bills as Neelum-Jhelum surcharge.

To another question, the official stated China inked the agreement to extend \$448 million loan for the said project in 2009 and promised to release the amount in 2010; now it is the end of 2011 and the NJHPC has not received the loan yet. The official further stated top-level intervention alone would help release the Chinese credit for the project of paramount importance.
