## **In this Edition**

*Growing concerns on Chinese presence in the PoK region has been reflected in some reports included in the current issue. Some argue that China is in Gilgit Baltistan for long, in view of the far reaching strategic and economic goals, it wishes to accomplish in the coming years. Being the crucial link with its all-weather ally, Pakistan, Gilgit Baltistan is of utmost importance to China. Hence, China wants to exercise influence on the PoK region to fulfil future requirements. There is resentment on increasing Chinese foothold in PoK at the local level. Leader of the Gilgit Baltistan United Movement (GBUM), Manzoor Parwana, recently slammed the Pakistan government in this regard. In a press release, Parwana urged the Pakistan government to make public the details of the Sino Pak Border Agreement of 1963, through which Pakistan handed over to China large tracts of territory belonging to Gilgit Baltistan (part of the former princely state of Jammu and Kashmir).*

*Unprecedented delay in starting off the Diamer Bhasha dam project has led to widespread apprehension regarding its future. There has been a series of conflicting reports- on one hand they suggest that funds have been arranged for the mega dam, while others note that smaller projects such as the Dasu dam (in Kohistan, Khyber Pakhtunkhwa) shall be given preference. The Diamer Bhasha dam is a huge multibillion dollar project and hence its future rests entirely on external funding. Lately, international financial institutions such as the World Bank have been reluctant to fund the project owing to its location in a disputed region and also due to its overall infeasibility.*

*Meanwhile, cross LoC trade was disrupted and a meeting was held between the two sides to resolve the issue. There is great deal of anguish amongst traders on both sides as the meeting failed to break the deadlock.*

## **“China expands footprint in Azad Kashmir, Gilgit and Balochistan”**

GILGIT: China is expanding its presence in Azad Kashmir, Gilgit Baltistan and Balochistan with the help of governments in Pakistan - be it dictators or elected regimes who have ignored interests of the local people. The ruling PML (N) government has hailed the relationship with China as being "higher than the Himalayas and sweeter than honey". During his visit to China in July 2013, Prime Minister Nawaz Sharif signed many agreements including an \$ 18 billion economic corridor from Xinjiang on China's western border to the Gwadar port in Balochistan. Sharif also called for an early completion of repair work on the Karakoram Highway, which runs from Xinjiang through Azad Kashmir. Experts say this is of economic and strategic interest to China and will not benefit the people of Pakistan or Azad Kashmir.

## **“Pakistan flips and flops on Bhasha Dam, then puts it on hold”**

In a series of gaffes, Pakistan's Finance Minister, Ishaq Dar first announced on 20th August that his government had supposedly arranged funds for the 4500 MW Diamer-Bhasha Dam estimated at a cost of 12 billion dollars. Pakistan media reported that the World Bank (WB) had withdrawn its condition of seeking a no-objection certificate (NOC) from India for releasing funds for the dam. Finance Minister Dar stated, "We have convinced the WB that it is not legally necessary to seek the NOC from a neighboring country" (read India).

If such a waiver had indeed been sought and provided, only Dar was aware of it. Neither India,

nor the World Bank, was aware of any change in the status of the proposed dam and its funding. No multilateral lending agency can fund projects in Pakistan Occupied Kashmir or Azad Kashmir as Pakistan calls it, because the ownership of the area is disputed. For the past eleven years, the Pakistani Government has been contesting this clause. While India has not given up its legitimate right over PoK and still considers Pakistan an illegal occupier of the land, its position on the dam is ambiguous. One source stated that so long as the project proposals legally state that it is located in an area, which is disputed between India and Pakistan and its final disposition, is for parties to the dispute to settle and the project is meant for developmental assistance to Kashmiris, and then, India could take a favourable approach.

## **“LHC petitioned for construction of Bhasha Dam”**

LAHORE: A lawyer, Chaudhry Ahmad Masood Gujjar, filed a petition in the Lahore High Court seeking directions for construction of Diamer Bhasha Dam to save billions of rupees. The petitioner has stated that the federal government had stopped the work on this important project. He stated that the president of Pakistan had on January 17, 2006 announced the decision for construction of five multi-purpose water reservoirs in the country within ten to twelve years. Gujjar stated that the Bhasha Dam was one of the most important projects and the Council of Common Interests had also unanimously approved its construction. He stated that now the government was not paying any attention to this project and postponing of the project would cause a loss of billions of rupees to public exchequer.

Gujjar argued that the physical work on the dam could be started and it could be completed in next seven years, but due to delay in the project the cost of the dam has been increased to \$14 billion from \$12.6 billion. He stated that Finance Minister, Ishaq Dar claimed to have convinced the World Bank to finance the Bhasha Dam without the requirement of no-objection certificate from India, and the Asian Development Bank has also agreed to become the lead finance for the project. The petitioner requested that the federal government be directed to immediately resume work on this dam and complete it to save the loss of Rs 24.843 billion, which has already been spent on this project.

The apex court issued directives to the district administration that the administration shall not allow the local operators of the Online Ads Business 'Click' to leave the jurisdiction of Mirpur.

### **“Barjees seeks expats' help for country's development”**

ISLAMABAD: Minister for Kashmir Affairs and Gilgit-Baltistan on September 2 stressed the need for cooperation of overseas Pakistanis for the progress and development of country. He was talking to Lord Qurban Husaain, Member British House of Lords, who called on him in Islamabad. ### **“Shelling near Kotli”**

MUZAFFARABAD: Indian and Pakistani troops traded fire in some areas of Nakial sector in the Kotli district of Azad Jammu and Kashmir on September 2. However, no casualties were reported. Official sources and local people noted that shelling took place in Lanjot, Balakot and Dheri Dabsi villages, but it remained largely from “post to post.” Confirming the shelling, Kotli Deputy Commissioner, Masoodur Rehman stated three state-run educational institutions in these villages had been closed for three days. “Shelling began after 10am and it restricted people to their homes and students to their respective institutions,” he further stated.

### **“G-B sets up task force to catch power thieves”**

GILGIT: The Gilgit-Baltistan government on August 31 constituted a special task force to take action against illegal power users, including official residences, offices, commercial and industrial units. Relevant officials stated the task force consisted of water and power department and the local administration officials which would conduct raids

under the supervision of magistrates. They stated that the task force would fine power thieves and defaulters and send them to jail.

Meanwhile, the Federal Investigation Agency conducted raids at the offices of the education directorate, education and finance ministers and secretary finance and disconnected power supply to them for using it illegally. The FIA team led by deputy director Babar Khan also raided some other offices and cut their power supply.

“The raids are part of the ongoing campaign against power theft throughout the country,” stated an official, adding cases were registered against meter readers for overlooking the power theft in their respective areas. The official stated the FIA seized 12 air conditioners only from the education directorate. He stated offices of ministers and secretaries turned out to be defaulters of the water and power department as they had not paid bills outstanding against them since long.

### **Peer Muhammad, “Inspection team report: Contractors embezzle Rs80m in G-B funds”**

ISLAMABAD: Contractors embezzled up to Rs80 million in funds in connivance with senior officers of Pakistan Works Department (PWD) without completing even a single project in a small tehsil of Ghizer district of Gilgit-Baltistan (G-B). This was revealed by an investigative report prepared recently by the head of the Inspection Team in G-B, which has commenced probing development projects across the region on the complaint that PWD officers have discharged funds by drawing huge commission from the contractors, who did not even bother to conclude a single project.

According to a report of the inspection team, in Yasin tehsil, development funds over Rs80 million have been disbursed for six projects well before the work even started. It was learnt that most of the contractors had affiliation with Pakistan Peoples Party and now they have joined Pakistan Muslim League-Nawaz (PML-N) in a bid to save their skin.

The new chief secretary, Mohammad Younus Dhaga, has suspended a score of senior and junior level officers of PWD by taking action against serious irregularities.

### **“Chief Minister of Gilgit-Baltistan plays double standards”**

### **“Inquiry ordered into GB appointments”**

GILGIT: The Gilgit-Baltistan chief secretary, Mohammad Yonus Dhaga ordered an inquiry into the recruitments made in the local education

department since 2008. Relevant officials noted on September 28 that there had been complaints that relatives of ministers and senior government officials were inducted through backdoor. They stated that degrees of teachers would be verified to know whether proper procedures were followed in their appointments. “Those who were given favour in sheer violation of law and merit will be fired after completing the due process,” stated an official on condition of anonymity. Meanwhile, the chief secretary also directed the works department to ensure timely completion of the ongoing development projects. He took serious note of delay in the projects.

### **Khaleeq Kiani, “Govt gets three bids for 590MW Mahl project”**

ISLAMABAD: The government on September 27 received three proposals from Chinese and local companies for setting up of 590MW Mahl Hydro power Project in Azad Kashmir at an estimated cost of about \$1 billion. The bids were opened by a committee, led by Secretary of Water and Power, comprising representatives of the governments of Azad Jammu and Kashmir and Punjab, besides the Water and Power Ministry, National Transmission and Dispatch Company and Private Power and Infrastructure Board. The companies which submitted their proposals by the deadline on September 27 included CWE Investment Corporation and Sino hydro Group of Limited (both from China) and Nishat Group Associated, led by leading businessman Mian Mohammad Mansha. The Mahl Hydro power Project is to be located on dual boundary of Rawalpindi, Punjab and Bagh in Azad Jammu and Kashmir, downstream of Kohala Bridge and upstream of Dhalkot Bridge linking AJK with Punjab. The proposals opened on September 27 in the presence of bidding companies would be evaluated by the bid committee on the basis of technical and financial credentials of the applicants within a month.

## **Waqar Ahmed, “On strategic projects and security issues”**

The Chinese ambassador in Islamabad has lately expressed concern over the lack of proper safety for its workers in Pakistan and conveyed the Chinese government's request for firm steps to be taken to ensure proper safety of Chinese workers, according to reports. The envoy, Sun Weidong, conveyed the Chinese government's concerns to Pakistan during his meeting with Interior Minister Chaudhry Nisar. “China needs more security for its engineers, workers they are not too much satisfied with the current available security in Gwadar, etc,” Weidong was quoted as saying by a senior official of the Interior Ministry.

Reports stated that the Chinese ambassador was dissatisfied over the poor security measures adopted for its engineers working in Sui, Gilgit-Baltistan and Karakorum Highway. Meanwhile, Chaudhry Nisar stated that his ministry was taking

solid steps and strictly following the SOPs for the safety and security of the Chinese working on projects in Pakistan. A committee is already working in the ministry whose task is to constantly look after the security of Chinese nationals in the country. He promised that “Pakistan would leave no stone unturned to look after the security and well-being of Chinese friends working in Pakistan.” There have been several alarming incidents with regard to the safety Chinese nationals in the country.

## **“Diamer jirga threatens to end govt support”**

### **Shabbir Mir, “Safe passage: Additional check posts to be set up along Karakoram Highway”**

GILGIT: The Gilgit-Baltistan (G-B) government decided to set up 17 more check posts on the strategic Karakoram Highway (KKH), which links the region to the rest of the country along with China. The decision was taken during a cabinet meeting held in Gilgit chaired by G-B Chief Minister Mehdi Ali Shah. “The purpose of erecting more check posts on the highway is to ensure a safe journey for commuters,” spokesperson for the Chief Minister’s Secretariat, Sajjadul Haq stated on September 25.

Over three dozen check posts manned by police and Frontier Constabulary personnel already dot the highway from Gilgit to Besham. However, two separate terror attacks on the route last year claimed the lives of at least 30 passengers. The importance of the highway has been compounded by Prime Minister Nawaz Sharif’s recent agreements with the Chinese government regarding a railway route passing through G-B.

### **Shabbir Mir, “Conflict of interest: Religious party calls for withdrawal of governance order”**

GILGIT: A regional religious organisation has called for the withdrawal of 'Self Governance Order 2009' in Gilgit-Baltistan (G-B), saying the order has blocked G-B's representation in the parliament. Under the G-B's empowerment and self-governance order, its status was brought at par with that of a province with a chief minister and governor installed for the first time in the region's history. The demand was made by Tanzeem Ahle-Sunnat Wal Jamaat's (TASWJ) General Secretary, Mohammad Nawaz and other leaders during a press conference held on September 23. “We want G-B to either be given the status of a 5th province or its affairs handled by the centre,” stated Nawaz.

The organisation was registered during 1956 and its office bearers, as they say, have no affiliation with the banned Ahle Sunnat Wal Jamat (ASWJ). They have representation in the Kohistan district of Khyber-Pakhtunkhwa. “The politics has not only damaged the interest of the people of G-B, it has also hampered the Kashmir issue,” stated TASWJ's general secretary. TASWJ leaders further noted that the development has eluded G-B since the new system of governance was introduced by the Pakistan Peoples Party.

### **“Gilgit Baltistan: Chinese Presence Causes Concern”, UNPO**

The chairman of the Gilgit-Baltistan United Movement (GBUM) demanded that the Pakistani

government clear up certain questions about Chinese presence in the region, and also disclose details about the 1963 border agreement between the two countries. Manzoor Parwana, the Chairman of the Gilgit-Baltistan United Movement (GBUM), demanded that the Pakistan Government come clean on Chinese activities in Gilgit Baltistan.

The government, he stated, should also disclose details of the Sino-Pak border agreement of 1963 under which Pakistan is stated to have handed over 19,360 square kilometers of Gilgit Baltistan to China. ### **Hasebur Rahman, "Rally to demanding justice for displaced Hunza Valley villagers"**

A terrible disaster unfolded in 2010 in the Hunza Valley in Gilgit Baltistan (formerly self-governing territory occupied by Pakistan since 1948). Protesting for people's rights in the aftermath of this disaster, three left-wing activists have been sentenced to 10 years jail. In July 2010, a huge landslide blocked the Hunza River and formed a gigantic 19 kilometre-wide lake, which submerged four villages. About 25 people lost their lives and 6000 people were displaced.

These internally displaced people (IDPs) were moved to the towns of Gilgit and Hunza. The Pakistani PM and other officials visited the IDPs in Hunza and promised compensation. More than a year later, people took to the streets in protest for not getting the promised compensation. The police killed a man and his son in broad daylight by opening fire on the peaceful protest. A riot followed. In the riot, 25 demonstrators were injured. When

Progressive Youth Front leader, Baba Jan and his comrades protested against this brutality, they were arrested. Most of those arrested were released soon after, but Baba Jan and four others were kept by police. They were tortured and brutally beaten. An international solidarity campaign helped secure Baba Jan's release after a year in detention, but his four comrades were kept in jail.

Following the massacre of security officials in Chilas, the headquarters of Diامر valley, several key suspects including the alleged mastermind of the Nanga Parbat incident, Qaribullah alias Hassan, his accomplices Mushtaq alias Commander Ghazi and four other suspects were arrested.

## **“Kashmiri traders hope UN meeting will ease tensions”**

*The News, September 29, 2013*

CHAKOTHI: Traders in Kashmir have expressed the hope that this weekend's meeting between the Pakistani and Indian prime ministers will ease rising tensions that have seen trade across the border grinding to a halt. Barter trade across the Line of Control (LoC) began in 2008 as part of the peace efforts. Mounting tensions and deadly skirmishes along the heavily militarised LoC in recent months have seen the trade come to a standstill for more than three weeks. Violence flared on August 6 when five Indian soldiers were killed in an ambush Delhi blamed on Pakistan, militants stormed an army base on the Indian side, killing 10. Prime Minister Nawaz Sharif and his Indian counterpart Manmohan Singh are due to meet on the sidelines of the UN General Assembly in New York this weekend the first top-level dialogue in three years.

## **Tariq Naqash, “Meeting fails to break impasse in intra-Kashmir trade”**

*Dawn, September 20, 2013*

MUZAFFARABAD: A meeting between officials from both sides of the Line of Control (LoC) on September 19 failed to break the impasse in intra-Kashmir trade. The meeting was held at the Chakothi-Uri crossing point where the barter trade was suspended on September 3, following India's refusal to accept items which it stated were not of Azad Kashmir origin. At September 19 meeting, the AJK side was represented by Trade and Travel Authority director general, Brig (retired) Mohammad Ismail and Trade Facilitation Officer in

Chakothi, Basharat Iqbal, while four officials came from across the LoC who introduced themselves as trade facilitation officers and representatives of the regional passport office in Srinagar. During the meeting Indian officials reiterated that in accordance with a notification issued by India's Central Board of Excise and Customs they could not accept items that were of Pakistani origin. While putting a ban on goods of Pakistani origin, the notification stated that Indian-origin goods would continue to be traded across the LoC until a decision about them was taken by India's ministry of home affairs.

## **Tariq Naqash, “India returns mangoes sent across LoC”**

MUZAFFARABAD: The intra-Kashmir trade through the two crossing points on the Line of Control (LoC) may meet a tragic fate as Indian officials have refused to accept items which they allege are not from Azad Jammu and Kashmir. On August 29, Indian authorities at their trade facilitation centre in Salamabad, on the other side of Chakothi, returned two trucks from AJK carrying mangoes, saying that the produce belonged to Pakistan, and not Azad Kashmir. The decision caused anger among traders on both sides. They went on a strike on September 3, saying the standard operating procedure (SOP) had no mention of the origin of a product. The same day, Indian officials conveyed to their counterparts in AJK that trade could not be carried on for some time because the traders on their side had gone on a strike.
