2. The bidders should submit valid PAN No. & GST No. with valid HSN code for relevant work.

3. Before submitting quotes, the firm shall inspect the site to fully acquaint itself.

4. The work shall be strictly carried out as per scope of work under the supervision of

Estate cell. 5. The MP-IDSA has the right to reject the quote at any stage without assigning any reason.

6. The quoted rates shall be inclusive of all taxes.

 Firm shall submit hard copy of all documents in sealed cover by Speed post/Hand Delivery in the tender box kept at reception.

8. MP-IDSA shall not be responsible for any injury of loss to any worker of the contractor that may take place while on work. Terms of Payment: Payments shall be made based on the satisfactory work done and based on the actual work, after deduction of 3% of contract value, which shall

be kept as performance security to cover the defects liability for a period of one year from the date of completion. During this period, any defect is found the same shall be got rectified immediately by the contractor. No extra payment will be made.

10. Rates: Rates should be quoted as item wised rate basis in the enclosed performa as per Annexure I attached with the quotation. All rates should be inclusive of GST.
