BOQ BID FOR SUPPLY OF SANITARY FITTINGS AT MP-IDSA

Eligibility Criteria: The bidder must fulfil the following eligibility criteria and should submit/upload the following document:-

1. The bidders should submit the related document in support of above supply issued by respective departments.
2. The bidders should submit valid PAN No. & GST No.
3. Before submitting quotes, the firm shall inspect the site to fully acquaint himself.
4. The work shall be strictly carried out as similar specification of work under the supervision of Estate cell.
5. The MP-IDSA has the right to reject the quote at any stage without assigning any reason.
6. The quoted rates shall be inclusive of all taxes.
7. MP-IDSA shall not be responsible for any injury or loss to any worker of the contractor that may take place while on work. Any compensation or expenditure towards treatment for such injury or loss of the life shall be the sole responsibility of the contractor. The contractor is solely responsible for any damage or injury or accident that may occur to any of his personnel working under his contract. No claim whatsoever arises to MP-IDSA.
8. **Terms of Payment:** Payments shall be made based on the satisfactory supply/work done and based on the actual work, **after deduction of 3% of contract value, which shall be kept as performance security to cover the defects liability for a period of six months from the date of completion.** During this period, any defect is found the same shall be got rectified immediately by the contractor. No extra payment will be made.
9. Scope of work is given in **Annexure I**.
10. Items to be fitted shall be of good quality/make of "Parryware" or equivalent.

11. The contractor shall include cost of supply & transportation of materials, labour, tools, etc. to the site. If damage occurred during fixing of items, which shall be replaced by firm without any extra cost.

12. **Statutory Deductions:** All the statutory deductions towards GST / TDS etc. shall be made from the bill/s as applicable as per the prevailing rates under the rules. TDS as applicable will be deducted from each bill of the contractor under the statutory rules.

13. **Penalty for Delay:** In case if the supply of tendered item is not completed within stipulated time of 15 days after receiving work order Rs.500/- per day shall be imposed on contractor.
