Leaving CSTO more likely than defreezing membership, says Armenian PM

Armenian Prime Minister Nikol Pashinyan said that it is now more likely that Armenia will quit the Russia-led Collective Security Treaty Organisation (CSTO) altogether rather than continue its suspended membership. "It is more likely that we will the CSTO leave than freeze membership," Pashinyan told a press conference in Yerevan on Thursday. The statement marks another escalation in Armenia's ongoing rift with the military alliance, which includes Russia, Belarus, Kazakhstan, Kyrgyzstan, and Tajikistan. Armenia suspended its participation in the CSTO in February 2024, with Pashinyan citing the bloc's failure to uphold security, sovereignty, Armenia's territorial integrity. The rift widened after Azerbaijan launched a large-scale military incursion into Armenia's internationally recognised territory in September 2022.

In recent years, Armenia has been actively seeking new arms suppliers around the world, and it now appears set to expand its military arsenal with the help of another European country—Poland. evidenced by the growing frequency of defence-related contacts between Yerevan and Warsaw. Just recently, Armenian enthusiastically media reported Armenia's Deputy Minister of Defence Karen Brutyan met in Warsaw with Paweł Bejda, State Secretary of Poland's Ministry of National Defence, to discuss bilateral cooperation in the military sphere. An agreement on defence cooperation between the two countries was signed as far back as September 2004. Subsequently, in 2019, Lubawa–Armenia significantly scaled back operations due to economic difficulties. The two sides only returned to discussions about expanding investment and increasing the company's capital share in July 2025.

Political scientists and wider civil society from Armenia and Azerbaijan don't often see eye to eye. After decades of war between the two countries their grievances run deep, with each side blaming the other for continued rounds of conflict. But experts in Yerevan and Baku can now agree on one thing: the meeting held in Abu Dhabi on July 10 between their heads of government was a moment of respite for the South Caucasus. After months without a major meeting between the two sides (the leaders met briefly at the margins of the European Political Community summit in

Tirana in May), Abu Dhabi was able to host their most comprehensive gathering in known history, attended by representatives who cover all key aspects of the Armenia-Azerbaijan peace process.

Azerbaijan, Baykar sign logistics and sales pact at major defence fair in Istanbul

Azerbaijan's Ministry of Defence has signed a "Logistics Support and Sales Agreement" with Turkish defence company Baykar, further strengthening defence cooperation between the two countries. The agreement was formalised during the IDEF-2025 International Defence Industry Fair, one of the world's leading events for defence and security technology. Baykar announced the development in a statement published on its official page on the social network X, expressing optimism about the growing partnership. "We hope that this cooperation will be beneficial for both brotherly countries," the company said, underscoring the close strategic ties between Türkiye and Azerbaijan. The agreement adds a new dimension to the defence collaboration between Baku and Ankara, especially in the field of advanced drone and aerospace systems. Baykar, known for its cutting-edge unmanned aerial vehicles (UAVs), including the Bayraktar TB2 and Akıncı drones, has emerged as one of Türkiye's flagship defence technology exporters. The company's UAVs have seen

extensive operational use in a number of conflict zones, including in Azerbaijan during the 2020 Karabakh war.

Azerbaijani firms tout deepening defence links with Türkiye

Officials from Azerbaijani defence firms participating in the International Defence Industry Fair (IDEF) 2025 praised Türkiye's defence sector and its strong relations with Azerbaijani companies, highlighting the distinct approach Turkish suppliers take toward their close ally. ITX-Motors Group Defence Director Zafer Cetinkaya said no matter what product they purchase, they ultimately find value for money in Türkiye. "Of course, due to the close proximity between the two countries, Turkish suppliers approach Azerbaijan differently and provide greater convenience," he told Anadolu Agency (AA) at Azerbaijan's national pavilion at IDEF. Cetinkaya also stressed that Türkiye has come a long way in both the automotive and defence industries since the 1970s. He noted that ITX has been working on armored vehicles for about two years, with one vehicle undergoing government testing in Azerbaijan for a month. "And we've finally successfully completed the tests ourselves. We're ready to put it into service with the armed forces by the end of the year," he added.

US, Bahrain to cooperate in civil nuclear energy

US Secretary of State Marco Rubio and Bahraini Minister of Foreign Affairs Dr. Abdullatif bin Rashid Al Zayani signed a nuclear cooperation memorandum understanding (NCMOU). Speaking to the signing ceremony, reporters at Secretary Rubio said that signing this important document "serves as the first step towards a deeper civil nuclear cooperation - an example that the United States is prepared to be a partner with any nation on Earth that wants to pursue a civil nuclear program that clearly is not geared towards weaponization or threatening the security of their neighbors." "And this is a - no one better to do it with than such a strong partner that we've been working with for so strengthens long. This only our relationship," he noted.

Cyprus emerging as a strategic space partner in Europe, Electronic Communications Department says

Cyprus is steadily advancing its position as a regional hub for high technology and a strategic partner in Europe's space sector, a press release issued by the Department of Electronic Communications of the Deputy Ministry of Research, Innovation and Digital Policy says. The Department, which now functions as the official Cyprus Space Office, represents the Republic at European and international space fora, promoting the policy on space, applications and international cooperation aimed at strengthening the domestic ecosystem, it is added. The adoption of the National Space Strategy 2022–2027, along with the passing of the 2023 Space Law, form the legal and strategic foundation for the sustainable development of space activities in Cyprus, it is noted. The country's efforts focus on four key areas: satellite communications, supported by advanced infrastructure such as the Cyta and Hellas Sat teleports and four Cyprusflagged satellites, earth observation led by **EXCELSIOR** project and the "Eratos-thenes" Centre of Excellence, satellite navigation with core Galileo and **EGNOS** ground installations cooperation with the European Space Agency (ESA), through more than 70 projects and €14 million in funding.

Cyprus submits formal interest for EU €150 billion SAFE programme

Cyprus has officially submitted its declaration of interest to participate in the European Union's new defence funding mechanism, the security Action for Europe (SAFE), Defence Minister Vasilis Palmas confirmed. Speaking to the Cyprus News

Agency, Palmas said the Ministry of Defence had submitted its formal expression of interest to the relevant EU committee, marking a key step in Cyprus' participation the €150 in billion programme. The SAFE initiative, launched by the European Commission, aims to strengthen the EU's defence capabilities through joint military procurement and low-interest loans to member states for the purchase of defence equipment. These loans will be facilitated through the Investment European Bank under favourable terms.

Georgia hosts Agile Spirit 2025 Multinational Exercise

Georgia is hosting the multinational exercise Agile Spirit 2025, which officially kicked off on July 21 in Turkey and opened in Georgia today, July 25, at the NATO-Georgia Joint Training and Evaluation Center (JTEC) in Krtsanisi. The drills will continue through August 8. "Agile Spirit 2025 is designed to enhance readiness, interoperability, and combined operational capabilities among participating armed forces," the Georgian Defence Ministry and the U.S. Army Europe and Africa said in their press releases. This marks the 12th iteration of Agile Spirit hosted in Georgia. This year, the drills bring together troops from Georgia, the U.S., Turkey, Germany,

Italy, Greece. Moldova, Romania. Bulgaria, Slovakia, Lithuania, Ukraine, and Poland. Armenia and Japan participating as observers. More than 2,000 military personnel are involved in this year's exercise, including over 800 U.S. service members. "Agile Spirit underscores the U.S. commitment to security and stability in the Black Sea region and highlights the importance of strong alliances and partnerships addressing shared security challenges," the U.S. side said. Launched in 2011, the biennial exercise focuses on "building and capacity increasing European leadership in European security through realistic, joint training scenarios."

Blinken admits Iran fulfilled its commitments to JCPOA prior to US withdrawal

Former U.S. Secretary of State Antony Blinken has acknowledged that Iran was in full compliance with the 2015 nuclear agreement prior to the deal's unilateral violation by the United States under President Donald Trump during previous term. He also admitted that military options would not produce a sustainable resolution to the nuclear issue, calling instead for renewed diplomacy. Speaking on a podcast hosted by CNN's Christiane Amanpour, Blinken claimed that before the latest round of Israeli aggression, Iran had agreed to limit its nuclear activities including uranium enrichment in coordination with European signatories. Blinken confirmed that the Joint Comprehensive Plan of Action (JCPOA) had been working effectively before Washington withdrew. "Iran was honoring its commitments under the deal—not only confirmed by international inspectors but also by our own intelligence sources," he said. According to the deal, Iran was permitted to enrich uranium to 3.67% using its own centrifuge technology.

Two decades of Nuclear Program: Iran enriches uranium as its people face growing poverty

The Islamic Republic calls uranium enrichment a "legitimate right" considers it necessary for "development" and use as fuel for nuclear power plants. However, the reality is that Iran has no nuclear power plant to use this fuel, and as long as sanctions remain in place, no country will build a nuclear power plant for Iran. Even Russia, despite repeated promises, has not yet begun construction of the second Bushehr power plant. The thousand-megawatt Bushehr plant is Iran's only nuclear power plant, which, when active, supplies less than one-eightieth of Iran's electricity consumption. Russia has not allowed the Islamic Republic to use its own nuclear fuel in this plant and has forced Iran to commit to purchasing Russianproduced fuel for it. Russia has the power to impose such demands on Iran because it

built the Bushehr power plant and must approve its fuel before it enters the reactor. However, Russia has not approved the quality of Iran's nuclear fuel. Ali Akbar Salehi, who headed the Atomic Energy Organization during the presidencies of Mahmoud Ahmadinejad and Hassan Rouhani, has said that Russia has not even allowed Iran to introduce its nuclear fuel into the Bushehr plant for testing purposes.

President: Depriving Iranian nation of its legal nuclear rights is unacceptable

President Masoud Pezeshkian has reiterated Iran's legitimate right to use nuclear energy for peaceful purposes, stressing that depriving Iranians of their legal rights is entirely unacceptable. In a telephone with conversation Armenian Minister Nikol Pashinyan on Saturday afternoon, Pezeshkian emphasized that the Republic is committed international law and has confidence in the transparency of its nuclear activities. Referring to the recent 12-day Israeli-U.S. war and the renewed push by European countries to revive negotiations, he said that Iran has never sought war, but has instead played an effective role in promoting peace and stability across the region. "We were attacked by the Zionist regime, in violation of all international standards and laws. Then, while negotiations were ongoing, the United States bombed Iranian nuclear facilities that were fully subject to

international inspection," Pezeshkian pointed out. He also criticized the silence of global institutions and governments — including the International Atomic Energy Agency (IAEA) — in the face of the aggressive and criminal assault on Iran.

Iran says replaced air defence systems damaged during Israel war

Iran has replaced the air defence systems damaged during its 12-day war with Israel last month, a senior army general said according to state media. Israel launched an unprecedented surprise bombing campaign against Iran in mid-June, prompting Tehran to respond with drone and missile attacks. Israel's strikes dealt a significant blow to the Islamic republic's air defences, which were repeatedly activated in the capital Tehran and across the country throughout the war. "The Zionist enemy sought to destroy Iran's defense capabilities, and some of our defense systems were damaged in that war," army operations chief Mahmoud Mousavi was quoted as saying by the official IRNA news agency. "The damaged defence systems have now been replaced," he added. Iran's air defence network includes systems like domestically built Bavar-373 and Khordad-15, designed to counter missiles and aircraft. Iran also installed Russia's S-300 air defense systems in 2016.

Iran not seeking nuclear weapons, false accusations used to justify attacks: Pezeshkian

Iranian President Masoud Pezeshkian has strongly rejected claims that the country is pursuing nuclear weapons, calling such accusations a fabricated narrative used by Israel and the United States to justify recent military aggression. At a ceremony commemorating cultural, artistic, media figures martyred during the recent 12-day war with Israel and the U.S., Pezeshkian said Iran has never had any intention of building an atomic bomb. The president condemned the attacks carried out by the United States and Israel, saying the two powers used the false pretext of nuclear weapons to strike Iranian civilian targets. "Under this excuse, they bombed our hospitals and residential neighborhoods, targeting defenseless civilians—women, children, and ordinary citizens," he said.

Group of Friends in Defence of U.N. Charter condemn Israel's illegal, unilateral actions

Representatives from member states of the Group of Friends in Defence of the Charter of the United Nations have expressed solidarity with the Iranian nation and condemned the attacks on Iran's nuclear facilities. In a meeting with this group in

New York, Deputy Foreign Minister for Legal and International Affairs of Iran Kazem Gharibabadi, appreciated member states of the group for their continued support for Iran, particularly during the 12-day imposed war. He dismissed baseless claims regarding "legitimate defense" and "preemptive attack" by the United States and the Israeli regime, saying that Iran's nuclear program has been under the supervision of the International Atomic Energy Agency (I.A.E.A.). In a briefing meeting with representatives from more than 110 U.N. member states in New York, Gharibabadi said that the aggression against Iran is a blatant crime and a historical test for the U.N. Security Council. During briefing, the Iranian diplomat described the Israeli regime as the main source of insecurity and instability in the region over the past eight decades.

Iran calls snapback baseless as nuclear deal is defunct for years

A senior Iranian diplomat dismissed European efforts to trigger the reimposition of United Nations sanctions under the 2015 nuclear deal as legally baseless, arguing that the accord has not been in effect for seven years. "The JCPOA has not been implemented for seven years, and the European countries halted their obligations after the United States withdrew from the deal," said Kazem Gharibabadi, Iran's

deputy foreign minister for legal and international affairs, in remarks to state news agency IRNA from New York. Gharibabadi's comments come ahead of a scheduled meeting on Friday in Istanbul between Iranian officials and representatives of the European E3— France. Germany, and the United Kingdom—to discuss recent diplomatic tensions and European statements regarding the activation of the so-called "snapback" mechanism. The snapback would restore UN sanctions lifted under the Joint Comprehensive Plan of Action (JCPOA), from which the US unilaterally withdrew in 2018.

Iran's nuclear industry to not be damaged by attacks

AEOI Spokesperson Behrouz Kamalvandi says that Iran's nuclear program is deeply rooted and will flourish again despite military attacks by Israel and the United States. Behrouz Kamalvandi, spokesperson for the Atomic Energy Organisation of Iran, stressed that the country's nuclear industry has strong foundations and cannot be harmed by military strikes or pressure. Referring to the 12-day Israeli-imposed war and the recent joint Israeli-American attack on Iran's nuclear facilities. Kamalvandi underlined, "The nuclear industry in our country is deeply rooted. And something that is rooted cannot be damaged by attacks or pressure—it will once again blossom." Tehran and Washington were engaged in negotiations led by Iranian Foreign Minister Abbas Araghchi and US President Donald Trump's foreign envoy Steve Witkoff and had conducted five rounds of indirect talks mediated by Oman when Israel launched a series of unprovoked aggressions, which upended the process.

Table of Iranian nuclear sites and related facilities

Iran has operated a number of facilities that carry out the different steps of the nuclear fuel cycle. Because of the dual-use potential of many of these facilities – they can be used to manufacture fuel for nuclear reactors or nuclear weapons – the international

community has long raised concerns that Iran could use this infrastructure and expertise to make weapons. Between June 12 and 24, 2025, Israel acted on those concerns and carried out airstrikes against a number of Iranian nuclear facilities. On June 21, 2025, the United States joined the air campaign and struck multiple sites using ground-penetrating munitions heavy ("bunker-busting bombs"). Some details about the damage caused to Iran's nuclear facilities have come to light, though it is unclear when the full extent of damage will be publicly known. Before the strikes, Iran's infrastructure included mines to extract natural uranium, mills that process uranium ore into concentrate known "yellowcake," and a plant that converts this yellowcake into uranium hexafluoride (UF6) gas.

Iran, EU3 begin second round of nuclear talks in Istanbul

They Deputy Foreign ministers of Iran and three European countries began a new round of talks in Istanbul, focusing on nuclear issues and sanctions relief. European diplomats arrived at Iran's consulate in Istanbul on Friday morning for negotiations with the Iranian delegation, headed by Majid Takht-Ravanchi and Gharibabadi, Kazem deputy foreign ministers of Iran. Referring to upcoming talks between Iran and the three European countries, Deputy Foreign Minister Kazem Gharibabadi stated that Iran's effort will be to examine what common solutions can be found to manage the current situation. The talks which are held at the deputy foreign minister level, mark the second round of discussions between Iran and the three European states in Istanbul.

Iran views Istanbul meeting as opportunity for Europe to correct its stance

Foreign Ministry spokesperson Esmaeil Baqaei says that a meeting between Iran and the E3 – comprising Britain, France, and Germany – presents a valuable opportunity for the three European countries to revise their stance on Iran's nuclear issue and serves as a test of their realism regarding the matter. Baqaei made the remarks in an exclusive interview with IRNA, published, the same day when representatives from Iran and the E3 meet in Istanbul, Turkey. The trio are members of the 2015 Iran nuclear deal officially named the Joint Comprehensive Plan of Action, or the JCPOA. In response to a question about repeated threats European countries to invoke the so-called "snapback mechanism" against Iran, the spokesperson stated that there is no justification for failing to remove Iran's nuclear file from the U.N. Security Council's agenda at the scheduled time.

Substantive progress in 'serious, frank, and detailed' talks with E3: Iran

on X after Posting the meeting, Gharibabadi said the Iranian delegation strongly criticized the European stance on the recent war of aggression against the Iranian people, and reaffirmed Tehran's principled positions on its nuclear rights. He noted that both sides had come to the table with concrete proposals and agreed to continue consultations in the coming weeks. The European countries, along with China and Russia, are the remaining parties to a 2015 deal - from which the U.S. withdrew in 2018. A deadline of Oct. 18 is fast approaching when the resolution governing that deal expires. At that point, all UN sanctions on Iran will be lifted unless a "snapback" mechanism is triggered at least 30 days before. This would automatically reimpose those sanctions, which target sectors from hydrocarbons to banking and defence. To give time for this to happen, the E3 has set a deadline of the end of August to revive diplomacy.

FM says Iran still has capability to enrich uranium

The Iranian foreign minister has said that his country still has the capabality to enrich uranium while it continues to be compliant with the fatwa by its Leader that bans possession of any WMDs. Abbas Araghchi made the comments in a recent interview with Financial Times (FT). He stressed to

the FT that 'the road to negotiation is narrow' as he lays out conditions for renewed diplomacy after war. The US must agree to compensate Iran for losses incurred during last month's war, the Islamic republic's foreign minister said, as Tehran hardens its position and imposes new conditions for resuming nuclear talks with the Trump administration. The minister further said that Iran would not agree to "business as usual" in the wake of the 12-day conflict with Israel, which the US briefly joined despite having been in talks with Iran.

Report: Of 3 nuke sites hit by US, only Fordo was badly set back; Trump rejected wider op

US strikes on three Iranian nuclear sites only caused significant damage to one of them, a new intelligence assessment has reportedly found, and discussions are said to have taken place between Israeli and American officials on the possibility of renewing strikes on the two other locations if Tehran doesn't agree to talks soon. The US strikes last month set back uranium enrichment activity at the underground Fordo nuclear site by some two years, NBC news reported, citing five current and former US officials with knowledge of the intel findings, which have been shared with lawmakers and officials in allied countries in recent days. The US outlet's reporting indicates, but does not state explicitly, that

the damage at Isfahan and Natanz, the two other sites, was less extensive, with some parts of them beyond America's massive bunker-buster bombs. The report said US officials think Iran could have the facilities back up and running in months.

The Defence Ministry announces that it has signed a half-billion shekel (\$150 million) deal to procure hundreds of light mobility vehicles for the IDF Ground Forces. The deal with the American manufacturer AM General included hundreds of Humvees, along with support and maintenance, the ministry says. The first dozen Humvees are expected to arrive in Israel this year, it says. The IDF uses Humvees for transporting troops, evacuating wounded, logistics supply, communications, and other purposes amid the war.

Romania has announced a major arms procurement deal with Israel, signing a framework agreement to purchase advanced short- and very short-range air defense systems (Shorad-Vshorad) valued at more than €2 billion (\$2.3 billion). The acquisition marks a significant upgrade in the country's military capabilities amid growing regional instability and persistent pressure from Western allies to bolster defense spending. The Romanian Ministry of Defense confirmed the deal on Monday, positioning it as a strategic move to protect national airspace and respond to escalating threats along the eastern flank of NATO. The systems, produced in Israel, are designed to intercept low-altitude aerial threats including drones, missiles, and aircraft. Romania shares a 650-kilometer (400-mile) border with Ukraine and has been directly impacted by the conflict. Over the past two years, fragments of Russian have repeatedly drones landed Romanian territory as Moscow targets Ukrainian ports along the Danube River.

According to its website, the company aims to be "the capital and the engine" behind a network of strategic partnerships that drive breakthroughs in defense tech. Netanyahu, who previously worked at the Israeli branch of the global consulting firm Strategy&, will join the initiative alongside Idan Keinan, a former staffer at the Prime Minister's Office and Group 11. Both will serve as senior associates, responsible for sourcing companies, building relationships, and conducting due diligence as needed.

New missile related munitions production complex targeted by Israel during 12-Day war

In our review and analysis of the potentially nuclear weapons related sites in Iran that were bombed by Israel in the recent military conflict, the Institute has come across missile related munitions production complex that witnessed severe damage to two key facilities between the 17th and 18th of June 2025. One of the targeted facilities was only about a year old, with construction completed in 2024. This site sparked our interest as it is clearly able to handle and test high explosives. contains an outdoor high-explosive test site and newly built facilities with multiple layers of security. In addition, there was almost no public information about the site pre-strike. The only publicly available information on the site may have stemmed from NCRI, which in 2010 alleged that there was a Ya Mahdi/Aerospace Industries Organization of Iran-associated site called "Ansar Al-Mehdi base" near Vandar. Poststrike, the Israeli Air Force published a short video clip of the still unnamed site, and identified it as a "site in Iran for the production of anti-tank missiles, which were transferred by the Iranian regime to its proxies."

'Growing evidence' war shattered Iran's nuke program, designs to build electromagnetic weapon

The damage to Iran's nuclear program and other weapons systems was indeed extensive and would be difficult to reverse, a leading analyst of U.S. foreign policy wrote, citing an Israeli source with detailed knowledge of the matter. The 12-day war last month dealt heavy damage to the mullah regime's plans to develop two types warheads of nuclear and an "electromagnetic pulse (EMP) weapon that could cripple Israel electronically," David Ignatius wrote in his weekly Washington Post column. One of the more underappreciated facets of Israel's devastating offensive was, per Ignatius, the assassination of Iran's entire cadre of nuclear scientists, resulting not merely in "a massive loss of talent" but also sending a message of deterence to younger Iranian nuclear specialists who now realize that participation in the regime's program amounts to a death sentence. It is not merely that "Iran is no longer a threshold nuclear state," as the source is quoted as saying, but its efforts to build two types of nuclear warheads, fission and fusion, were laid to waste. Thus, even if Iran still possesses enriched stockpiles of uranium, weaponization would be extremely challenging, it is understood. Israeli attacks halved Iran's arsenal of 3,000 ballistic missiles and reduced by 80% its 500 missile launchers. The timing of the war prevented Tehran from realizing its plan to boost its ballistic missile stockpile to 8,000.

Jordan, Iraq and Egypt say Israeli strikes in Syria jeopardise regional stability

Jordan, Iraq and Egypt condemned the Israeli strikes that targeted Syria this week, stating that these actions are a blatant violation of sovereignty and international law. Israel struck Syrian forces and military vehicles as they approached the southern city of Sweida to restore stability after deadly clashes erupted in the region between the Druze sect and Bedouin tribes this week. Israel struck the Svrian government's military headquarters in the capital, Damascus, as the Israeli prime minister and minister of defense said they were intervening to "protect" the Druze, who mainly live in Suweida. The Jordanian Ministry of Foreign and Expatriate Affairs condemned Israel's airstrikes, saying that they represent a dangerous escalation that jeopardizes Syria's stability and security.

UAE and Jordan conduct new air drops to Gaza as Emirati aid convoy arrives

The UAE and Jordan air dropped critical aid into the Gaza Strip for a fourth day as an Emirati convoy of 58 lorries brought more humanitarian supplies into the enclave. Jordan's Petra news agency said the airdrops were carried out by two C-130 Royal Jordanian Air Force planes and an Emirati counterpart. It added that 16 tonnes of food and baby formula were delivered to various areas of Gaza Strip, bringing the total cargo dropped over the past few days to about 73 tonnes of essential supplies. A Belgian aircraft carrying medical supplies and food worth €600,000 (\$690,000) will "soon" fly to Jordan and remain on standby to conduct air drops, said the defence and foreign ministries in Brussels. Gaza's hospitals have recorded seven new deaths from malnutrition and starvation in the past 24 hours, the Health Ministry said. This takes the death toll from starvation during the conflict to 154 – including 89 children - the ministry said. At least 60,138 Palestinians have been killed and 146,269 wounded since the Gaza war began, the ministry said.

Kuwait deploys Turkey's Battle-Tested Bayraktar TB2 UCAVs in Strategic Leap for Gulf Security

The high-profile event was graced by Kuwait's Defence Minister, Sheikh Abdullah Ali Abdullah Al-Sabah, who underscored the strategic significance of this acquisition in bolstering Kuwait's surveillance, reconnaissance, and precision strike capabilities in an increasingly volatile regional security environment. "This is an important step development of the Kuwaiti capabilities, especially in the areas of surveillance. reconnaissance and intelligence gathering," said Sheikh Abdullah during the commissioning ceremony. The commissioning follows a landmark bilateral defence agreement signed in 2023, in which Kuwait inked a US\$370 million (approximately RM1.75 billion) contract with Turkish defence aerospace company Baykar for procurement of a complete Bayraktar TB2 system.

UK's Starmer, Oman's sultan agree to deepen ties in energy, defence and tech

Saudi Arabia unveils \$6.4 billion investment package for Syria

According to the IDF, the missile was successfully neutralised before it could impact Israeli territory. At 5:50 a.m. local time, air raid sirens—known in Hebrew as "Tzeva Adom"—were activated across central Israel. The alerts were heard in Tel Aviv, Beit Shemesh, Kiryat Gat, and Ashdod. Ben Gurion Airport briefly suspended operations during the alert but resumed service shortly afterward. No missile debris was found near the airport, and the facility sustained no damage.
