DOSSIER TO PUT PAKISTAN BACK ON FATF 'GREY LIST'

## Delegates Receive Support of World Leaders over India's War on Terror

s part of India's diplomatic outreach, seven multi-party delegations travelled to 33 capitals of countries from across the globe to help the international community understand Pakistan's terrorism directed at India response to terror, especially in view of the April 22, Pahalgam terror attack that claimed 26 lives.

In this regard, several countries including Saudi Arabia, France, Italy, Indonesia, South Africa, Panama, etc. have voiced solidarity with India's zero-tolerance approach.

As member of Shiv Sena MP Shrikant Shinde led India's all-party delegation mission to the Democratic Republic of Congo (DRC), Director General of MP-IDSA Ambassador Sujan Chinoy stated that it is "wonderful to see India speak with a united voice" and convey its zero-tolerance policy against terrorism at the international level.

Meanwhile in Paris, Indian parliamentary delegation headed by

BJP MP Ravi Shankar Prasad met French Parliamentarians led by Thierry Tesson, the president of the India-France Friendship group, and conveyed to him India's firm stance against terrorism emanating from Pakistan.

During a press conference in Paris, Mr Prasad said that the distinction between Pakistan and terrorism has withered away.

In New York, senior Congress leader Shashi Tharoor said: "No one sitting in Pakistan is going to be allowed to believe that they can just walk across the border and kill our citizens with impunity. There will be a price to pay and that price has been going up systematically."

Meanwhile, AIMIM leader Asaduddin Owaisi, who is part of an all-party Indian delegation visiting some West Asian states, said in Kuwait that "Pakistan must be brought back in the FATF grey list."

### BSF Strike 70 Pakistan Posts, Three Terrorist Launchpads

he Border Security Force's (BSF) Jammu frontier inspector general (IG) Shashank Anand said on 27 May that the force had inflicted heavy damage Pakistan during Operation on Sindoor by destroying over 70 posts of Pakistan Rangers and three terrorist launch pads across the 200km-odd international border.

Addressing the media in Jammu, Mr Shashank Anand said, "Following Pahalgam terror attack, Pak Rangers had suspended activities in their posts and had fallen back.

"However, we had prepared well for any unprovoked firing."

Thus, the BSF had heightened surveillance and was on high alert. "We dominated the IB and our men and women guarded posts which are beyond border fence (towards zero line)," the IG added.

"The BSF, on the night of May 8, observed movement of a big group of suspected terrorists opposite Samba sector. We tracked their movement

and launched a pre-emptive strike," Mr Anand said. He added that their strike took Pakistan Rangers by surprise, and they opened fire on BSF posts.

"As we were well prepared, we launched an attack and inflicted heavy damage on Pakistan, destroying over 70 posts opposite IB and three terror launch pads in Sialkot between May 8 and 10," the Inspector General of BSF said.

In addition, Pakistan resorted to unprovoked firing near the Akhnoor sector on May 9. Mr Anand said: "Between May 9 and 10, heavy firing was reported along the Akhnoor sector. The BSF responded by targeting their Looni terror launch pad."

The IG said the BSF intended to name two BSF posts after sub-inspector Mohammad Imtiyaz and Constable Deepak Kumar, who were killed on duty in RS Pura sector during the conflict. — <u>Hindustan</u> Times

# **India Preparing Dossier to put Pakistan on FATF 'Grey List'**

India is intensifying its diplomatic campaign against Pakistan by preparing a strong case at the Financial Action Task Force (FATF) to put Pakistan back on the "grey list" over its neighbour's continued and systemic failures to clamp down on money laundering and terror financing, a government source reportedly told the Press Trust of India (PTI).

According to the report, New Delhi will highlight Islamabad's failures to comply with anti-money laundering (AML) and counter-terror financing (CFT) obligations through evidence presented in its dossier.

The development comes in the wake of the Pahalgam terror attack and in the wake of growing evidence regarding Pakistan's continued shelter and finance UN-designated terrorist groups.

A senior Indian government official is said to have told PTI: "We will be taking it up (with the FATF)," when asked if New Delhi would press for Pakistan's grey listing.

The government is said to be preparing a dossier, which might be submitted at the FATF plenary meeting, scheduled to be held this month.

It is reported that India has gathered ample evidence to argue that Pakistan's compliance with FATF recommendations are insufficient, superficial and incomplete.

This is particularly the case regarding Pakistan's commitment to curb the financing of United Nations-designated terrorist groups, such as the infamous Lashkar-e-Taiba (Let) as well as Jaish-e-Mohammad (JeM).

#### **Key Suspect of Narco-Terror Module Held in J&K**

n a major breakthrough, the State Investigation Agency (SIA) in Jammu and Kashmir apprehended Abdul Rashid Mir, resident of Amargarh Sopore on 28 May, who was at large for the last two years. An official said that the accused is a part of cross border narco-terror module operating in the valley.

He said the narcotics and small arms were smuggled across the border by terror operatives of LeT into Sopore town and thereafter peddled throughout the valley among the youth. During the course of investigation of this case (FIR 19/2022), the official said that eight members of the narco-terror module have been arrested by SIA, Kashmir so far. — *Rising Kashmir* 

#### 10-Year Jail to Hizbul Terrorist in Uttar Pradesh

A court in the Uttar Pradesh city of Moradabad has sentenced Hizbul Mujahideen terrorist Ulfat Hussain to 10 years of rigorous imprisonment for being involved in terror activities, the additional district government counsel said on Tuesday. Moradabad Additional District and Sessions Judge II Chhaya Sharma also imposed a fine of Rs 48,000 on the convict in the order pronounced on Monday, said ADGC Suresh Singh. After the pronouncement of verdict, the convict was sent to jail under tight security.

Ulfat Hussain alias Mohammad Saiful Islam, a resident of Poonch district in Jammu and Kashmir, has been involved in terrorist activities since 2002 and was absconding after being granted bail in 2008, said the ADGC. The Moradabad court had issued permanent warrants against him in both January, 2015 and March 2025. — *The New Indian Express* 

#### Suspected Babbar Khalsa Terrorist killed in Amritsar

suspected terrorist was killed in a powerful explosion at the Majitha Road Bypass area of Punjab's Amritsar, officials said. The blast took place on morning of 27 May at around 9.30am. According to local media reports, the man's arms were blown off in the blast. Initially treated as a case of mishandling explosive material, officials are now suspicious the deceased was member of terrorist group, Babbar Khalsa. — *Hindustan Times*
