Russia intensifying use of chemical weapons in Ukraine, Dutch intelligence reports

Russia is escalating the use of chemical weapons against Ukrainian forces, the Netherlands Military Intelligence (MIVD) reported on July 4. Russian troops use banned chemical agents as psychological warfare to panic Ukrainian forces, forcing soldiers from dugouts and trenches with gas grenades dropped by drones, making them easy targets for subsequent drone or artillery attacks. According to MIVD report, it was previously known that Russia uses tear gas, but now intelligence has confirmed the use of chloropicrin — a substance that can kill in high concentrations in enclosed spaces. Use of chloropicrin, banned under international law, was discovered by the Netherlands Military Intelligence and Security Service (MIVD) and General Intelligence and Security Service (AIVD) together with the German foreign intelligence service BND.

Dutch and German Intelligence say Russia increasingly uses chemical weapons in Ukraine

Dutch and German intelligence agencies said Friday that they had gathered evidence of Russia's growing use of chemical weapons in Ukraine and called for tougher sanctions against Moscow and continued military support for Kyiv. The Dutch military and

general intelligence services, MIVD and AIVD, along with Germany's foreign intelligence service BND, said they had identified the chemical agent chloropicrin, which "can be fatal when used in high concentrations in enclosed spaces." In May, the United States imposed sanctions on Russia for its alleged use of chloropicrin and tear gas in violation of the Chemical Weapons Convention. The Kremlin rejected the accusations as "baseless." The Dutch and German agencies said Russia's military leadership and its radiological, chemical and biological defense forces were "supporting" and "actively facilitating" the use of banned agents on the battlefield. "The use of both teargas and chloropicrin by Russian troops has now become standard practice and commonplace and will highly probably remain a threat in the future," they said in a joint statement.

Ukraine urges investigation into alleged Russian chemical weapons use

Ukraine asked the global chemical weapons watchdog in The Hague on Tuesday to investigate the alleged use of banned toxic munitions by Russia against its forces. A request to establish an investigation was submitted by Kyiv to the governing body of the organisation for the Prohibition of Chemical Weapons (OPCW). It followed Dutch and German intelligence agencies on Friday saying they had evidence of widespread use of illegal weapons by Russia along the frontline. Agency chief Fernando

Arias said in a statement to the OPCW's Executive Council that in view of the alleged frequent use of dangerous chemical agents his office would step up monitoring of activity along the Russia-Ukraine conflict line. He invited Ukraine to discuss its proposal with member states, a majority of whom may be needed to support such an investigation. The OPCW created a similar team in 2018 to examine accusations of chemical weapons use in Syria. The Investigation and Identification Team found that Syrian government forces and Islamic State militants had used banned chemical weapons in the civil war that began in March 2011.

OPCW trains experts with live chemical agents

At a secured facility deep in the Slovak countryside, the air is thick with anticipation. Wearing full protective suits, trainees methodically check every strap, every seal, every valve. Under the watchful eyes of seasoned instructors, they prepare to enter the "hot zone" – a high-security area where live chemical warfare agents are handled with utmost precision. This is no simulation. This is one of the few places in the world where experts train with actual chemical warfare agents – deadly substances capable of causing harm or death upon exposure. The stakes are high, and the learning is real. "In chemical emergencies, theoretical knowledge alone is not enough," said Pavel Donoval, Director of Exercise of Live-Agent Training Course for Experts at the NBC Training and Testing Centre. "Training with live chemical agents conditions you to respond under pressure. It builds the muscle memory, judgment, and confidence that can mean the difference between life and death." This immersive training is part of the International Live Agent Training Course for Experts, organised by the Organisation for the Prohibition of Chemical Weapons (OPCW) in close partnership with the Government of Slovakia. Held annually at the NBC Training and Testing Centre, the programme is one of the few in the world that allows participants to work hands-on with real, highly toxic chemical warfare agents – all within a rigorously managed and secure setting.

On Tuesday, Trump pledged to tackle yet another complicated challenge by spearheading an effort to use artificial intelligence (AI) to verify compliance with the Biological Weapons Convention (BWC).

Disturbing Reports of Sudan's Military Using Chlorine Gas

The United States government sanctioned General Abdel Fattah al-Burhan, the head

of the Sudanese Armed Forces (SAF) and Sudan's de facto head of state, in January 2025, alleging that the SAF had used chemical weapons, but did not publish any evidence for the claim. But a new investigation by France 24, a French broadcaster, provides the first public elements to corroborate the US allegations, indicating that Sudan's military may have used chlorine in two incidents in September 2024. The use of chlorine, a common industrial chemical, as a weapon is prohibited under the Chemical Weapons Convention, to which Sudan is a party. Exposure to chlorine or its compounds can lead to diverse symptoms from reddening and itchiness to shortness of breath and even death. Use of chlorine as a weapon would be a serious violation of the Chemical Weapons Convention and is a war crime under the Rome Statute of the International Criminal Court. The France 24 Observers, the network's digital investigation unit geolocated photographs and videos posted in September 2024 at the Garri military base and the nearby Jaili oil refinery north of Khartoum, both at the time under the control of the Rapid Support Forces (RSF), the SAF's opponent in the country's armed conflict.

OPCW equips experts from 31 developing and transitioning economies as 'force multipliers' for global chemical safety

The Organisation for the Prohibition of Chemical Weapons (OPCW) successfully concluded the 26th edition of its flagship capacity-building initiative, the Associate Programme, on 25 September 2025, at the OPCW Centre for Chemistry and Technology. The intensive nine-week programme equipped 31 participants from 31 States Parties—including first-time representatives from Bahrain, Kuwait, and the State of Palestine—with advanced technical and managerial skills for the effective and non-discriminatory implementation of the Chemical Weapons Convention (CWC). The Programme's multidisciplinary approach combined legal, academic, and practical training across multiple locations. Participants began with

education on the legal aspects of the CWC and key functions of the OPCW, with a focus on the verification regime and national authority arrangements. In the academic segment, conducted in collaboration with the University of Surrey in the United Kingdom, participants acquired knowledge and skills essential for chemical industry operations, including material balance, chemical engineering, and health and safety measures.

Ricin poison terror plot busted, Telangana 'doctor', 2 from UP arrested: Gujarat ATS

The Gujarat Anti-Terrorist Squad (ATS) Sunday said it arrested three men with “terror links”, including a doctor with a “Chinese medical degree”, who were allegedly trying to produce Ricin – a lethal toxin on international chemical and biological weapons lists. The accused had allegedly conducted a recce of several sensitive locations in Lucknow, Delhi and Ahmedabad to carry out a “terror attack in the country”, a senior ATS officer said. Three pistols, 30 live cartridges and nearly four litres of castor oil were seized from the possession of the accused, the ATS said. The ATS identified the three arrested accused as Dr Ahmed Mohiyuddin Saiyed, 35, a resident of Hyderabad, Telangana; Azad Suleman Sheikh, (20), a tailor from Shamli, Uttar Pradesh; and Mohammad Suhail Mohammad Saleem Khan, 23, a student and a resident of Lakhimpur Kheri, Uttar Pradesh.

Secret U.S. Memo Authorising Drug-Boat Strikes Cites Chemical Weapon Threat

A classified Justice Department brief authorising strikes on drug-smuggling boats describes fentanyl as a potential chemical weapons threat, according to a House member and another person familiar with the memo. The lengthy document by the department's Office of Legal Counsel outlines the Trump administration's still-secret legal justification for the continuing military operation, which has sparked sharp criticism from Democrats and some Republicans since the strikes began in September. The mention of fentanyl is one of many points in the brief, which was drafted over the summer to justify the use of military force against drug traffickers. It notes that fentanyl has been weaponised in the past. In 2002, Russia used aerosolised fentanyl to quell a hostage crisis at a Moscow theater, killing more than 100 of the roughly 700 people being held in the rescue attempt.

OPCW Director-General receives Russia’s Deputy Minister of Industry and Trade

Organisation for the Prohibition of Chemical Weapons, November 28, 2025

The OPCW Director-General, Ambassador Fernando Arias, met in The Hague with the Deputy Minister of Industry and Trade of

the Russian Federation, Mr Kirill Lysogorsky, on the margins of the Thirtieth Session of the Conference of the States Parties (CSP-30). The meeting focused on the importance of the Chemical Weapons Convention (CWC) and the commitment of all 193 States Parties to the complete and permanent elimination of chemical weapons. Director-General Arias reaffirmed that all States Parties to the CWC must adhere to their obligations under the Convention and reinforcing the global norm against chemical weapons remains essential for international peace and security. Director-General Arias outlined the Organisation's efforts to prevent the re-emergence of chemical weapons, noting that emerging technologies such as artificial intelligence pose both new challenges and opportunities. He emphasised the growing role of the OPCW Centre for Chemistry and Technology in enhancing the Organisation's capacity to detect, analyse, and respond to potential chemical weapons threats.

SIPRI hosts workshop on technological opportunities for the biological weapons regime

Stockholm International Peace Research Institute, December 1, 2025

The Stockholm International Peace Research Institute (SIPRI) held a closed-door workshop on 20–21 November to examine how emerging technologies, including artificial intelligence (AI), could support and strengthen the biological weapons prohibition regime. As part of a project funded by the UK Foreign, Commonwealth and Development Office, the meeting brought together government officials and experts from academia, the private sector, civil

society and international organisations for two days of discussions. The workshop focused on how new tools and digital systems are already being used—and may be used in the future—to reinforce core functions of the regime, including biosafety laboratory operations, export control implementation, and approaches to compliance and enforcement. Across thematic sessions, participants discussed export controls in an era of digital trade, oversight of high-containment laboratories, responsible innovation and the use of digital platforms for traceability, screening and access control. Smaller group discussions examined practical cases involving AI-assisted gene screening, laboratory governance and digital traceability systems.

The world is not yet "adequately prepared" to deal with the threat of bioterrorism, External Affairs Minister S. Jaishankar said in New Delhi on December 1, 2025. Yet the BWC still lacks basic institutional structures," said Mr. Jaishankar.
